- Remove and replace existing 8” concrete paving, trench plates, and asphalt. Reference Photos attached.

- Provide and install connection to existing 8” waterline, Reference Plans attached.
- Provide and install approximately 200 ft of 6” DR-14 PVC (hot tap required).
- Provide and install 6” PIV assembly and valve box.
- Conduct water testing and ensure trench safety.
- Provide haul away dumpster or dispose of spoils offsite.
