- Customer to provide all required naming door conventions, access levels, etc. for programming of the system. Customer is responsible for card holder entry.
- Customer to provide (1) patch panel port and/or (1) network POE switch port.
- ACI assumes all existing hardware and wire is in good condition and in working order. If issues are found with existing hardware; Troubleshooting, repair, and/or replacement of existing devices will be done at additional cost and is not part of this proposal.
- ACI is not responsible for any repairs needed to conceal damage or cosmetic blemishes remaining after removing or replacing exiting equipment.
