## **MEMORANDUM OF DONATION**

## KNOW ALL MEN BY THESE PRESENTS:

Whereas Johnson County is authorized to act and does act by and through the Commissioners Court of Johnson County, pursuant to V.T.C. A., Local Government Code Section 81.032 and / or V.T.C.A., Transportation Code Section 252.214 to accept donations of property or funds.

## THEREFORE:

Donor does hereby donate and transfer to Johnson County the materials and/or funds described below:  Installation of turn lane into Country Meadows off of CR 203 valued at \$16,000

Donated funds shall be paid to the County for disbursement pursuant to any conditions delineated or approved by the Commissioners Court.
