PUBLIC ANNOUNCEMENTS

PA1. Announcements from County Commissioners Regarding County and Precinct Events

Comm. Bailey stated that he had a big announcement and that they would be pouring concrete at 3 A.M. Wednesday at Old Foamy Road. He stated that he is hopeful that they can get it done. He also commented that they are going to widen that road about 4 more feet and he is hoping by the middle of July it will be ready for use.

Comm. Woolley stated that he had to brag on the Grandview Zebras girls softball team as they made it to the final four in the state tournament, made it to the final game, and ended up being runner-up state champion. He stated that the score was 3 to 2 in extra innings and that it was the best record in Grandview's history for any girls softball team.

PA2. Presentation of the Texas Historical Commission's 2023 Distinguished Service Award to Johnson County Historical Commission

Judge Boedeker presented the Texas Historical Commission's 2023 Distinguished Service Award to Sandra Neeley and other members of the Johnson County Historical Commission.

PA3. Update on the Status of the SOMA Global Project

IT Director Dan Milam presented the slideshow of the SOMA project update.

Comm. Bailey asked why they were behind on the project and over budget.

Mr. Milam stated it was due to issues coordinating with all of the agencies.

Comm. Bailey asked Mr. Milam if the money that was over was going on consulting.

Mr. Milam replied that it was on the consulting side.

Judge Boedeker thanked Mr. Milam for the update and said that the Court would want additional updates as the date gets closer.

Comm. Howell asked Mr. Milam if the delay had mostly been in coordination.

Mr. Milam replied that yes it had.

Judge Boedeker added that his office had been working with Mr. Milam and that they were going to reach out to Senator King's Office to get that through DPS as there have been communication delays.

PA4. Update on Status of the Construction/Renovation of County Buildings by Joshua Green, Facilities Management Director

Facilities Management Director Joshua Green presented and stated that it was a pretty active weekend for facilities management as they had projects going on at the Guinn Justice Center that wrapped up at midnight Friday evening into Saturday morning. He stated that they had a flagpole and crane in front of the Historic Courthouse Saturday morning and left about 4:30 P.M. because they were doing some flagpole repair and putting some material on the roof. He stated that to make record of it, the flag is not currently flying because after the assessment, the flagpole needed some additional repairs and that the contractor made the recommendation that it was a good time to remove the flag and the cable so there was no more damage done. He stated that the contractor will come to the next Commissioners Court to do a presentation so that the court can decide which direction is the best way to go. He commented that they are still tidying up some things at the 911 Call Center, that everything is going smoothly, and that they will be installing additional monitors this week.
