Subject: Johnson County Precinct 1 Constable Building Revision 2

This bid includes all the labor and material to accomplish the following scope.

Upstairs Renovation Scope:

- Interior renovation of the upstairs training room, offices, stairwell and open areas including: wall
 repair, TBT, paint, fabrication of partition wall and finish, replacement stained ceiling tiles,
 demolition of flooring and installation of carpet squares, demo existing millwork, fabricate and install
 new millwork including upper/lower cabinets and extended plastic laminate countertop, retread
 stairwell with carpet squares and new bullnose treads, demo and replacement of bathroom vanities
 utilizing existing fixtures, demo and replacement of bathroom wall panels, new bathroom mirrors.
- In the stairwell, install one new 2'x2' LED flat panel fixture in the drop ceiling at the bottom of the staircase. Relocate existing stairwell light switch at the top of the stairwell and install one new light switch at the bottom of the stairwell
- The 1st floor stairwell door: remove door and convert to a cased opening

Awning Scope:

 Along the south face of the building construct a r-panel style awning approx 55'x18', matching existing awning conditions.

Machine Shop Offices Scope:

• In the two offices in the machine shop, relocate existing doors and frames to the opposite wall, relocating light switches as well. Enclose walls, TBT and paint. Install new r-panel in machine shop to match existing conditions.

Hallway Reconfiguration Scope:

• In the interior offices, reconfigure 3 office doors to allow for the relocation/fabrication of new hallway. This includes relocating existing light switches and receptacles, modification of the ceiling grid system, drywall repair, TBT and painting

Schedule: 4-6 weeks for scheduling, 2 months to complete scope. Schedule is highly susceptible to weather conditions

Notes:

- Awning Scope: Work to existing windows and exterior doors is not included in this quote
- Permits and bonding are not included in this bid.
- Bid expires 30 days from the date of this letter.
- Work to be completed during normal business hours.
