BE IT KNOWN that on the 8th day of July 2024, the Honorable Commissioners Court of Johnson County, Texas, met in Regular Session at the Johnson County Courthouse thereof, in the City of Cleburne, Johnson County, Texas, for the purpose of transacting any and all business that may lawfully be brought before the same. The meeting was called to order at 9:00 A.M. with all members present. Judge Boedeker stated for the record that all the Members of the Commissioners Court were present, along with other officials necessary for today's meeting.

PA1. Announcements from County Commissioners Regarding County and Precinct Events

Comm. Woolley gave accolades to the Sheriff's Office, especially to Captain Danny Rogers and Retired Detective Steve Shaw for getting to the bottom of this angel baby doe case after 22 or 23 years. He stated that it was a phenomenal situation to come to some closure on that as it has been a big black cloud for a lot of investigators and Sheriff's officers for a long time. He congratulated those two and anyone else that was on that team.

Comm. Bailey asked for patience as they improve the flood damage, even with the weather coming in it shouldn't slow them down too much. He stated that they are working as hard and as fast as they can to get the roads opened back up before school starts. He said that it might be 60 days on a couple of the roads because the concrete has to cure.

Comm. Howell commented that Comm. Bailey did have the Old Foamy Bridge poured.

Comm. Bailey replied with a yes and that they are widening the road and making a lot of improvements.

Personnel Director Randy Gillespie presented a plaque from TAC to the Court recognizing this Court's participation with our TAC Association of Counties Risk Management Pool for 50 years. He presented the plaque to Judge Boedeker.

Judge Boedeker thanked Mr. Gillespie and he stated that they appreciate their partnership with TAC.

Comm. Woolley stated that he understands that the Court is compelled to approve this, but the entire process has been very concerning to him and that he cannot support either one of these.

Comm. Bailey commented that he understood, but this is not a district court and that this matter is going to have to be settled in a district court. He stated that the lawyers here representing both parties know that. He stated that the State of Texas says that they must and that they shall approve if it meets the requirements and that is where we are. He stated that as a county and as a state, we cannot stop what is coming. He stated that this Court does not decide that and it cannot. He stated that for those who are listening, watching, and those who are here being represented today, understand that this Court does not have that authority, so that is why the Court had to approve it. He stated that he understood the concern for Comm. Woolley's residents and that the same situations arise in their precincts.

Judge Boedeker thanked both commissioners and stated that the Court has a limited set of authority from the State of Texas and that they do what the law tells them to do. He stated that they consulted with legal counsel about this matter and they believe that the only legal path forward today was to approve the plat. He added that it does not indicate whether anyone likes it or dislikes it, but it is a matter of what the law tells the Court to do today. Judge Boedeker commented that the Court appreciates the participation that they have gotten on this item and when people come and tell them what is going on out in the County. He stated that this is why they have public hearings and open meetings because they want to know all sides of an issue before they act, even though on this particular issue they are pretty limited on what they can do. He stated for the record that they had voted and item A4 carried four to one with Comm. Woolley voting against and that item passed.
