
COMMISSIONERS COURT ORDER GRANTING AN EXEMPTION UNDER SECTION 262.024, LOCAL GOVERNMENT CODE, FROM THE BIDDING REQUIREMENTS OF SECTION 262.023, LOCAL GOVERNMENT CODE, UPON THE COMMISSIONERS COURT FINDING THAT THE LABORATORY TESTING SERVICES OF EUROFINS LANCASTER LABORATORIES ENVIRONMENT TESTING, LLC ARE PROFESSIONAL SERVICES

The Johnson County Commissioners Court met on September 9, 2024 in regular session for the consideration of purchasing laboratory testing of soil, water, animal tissue, and other items by Eurofins Lancaster Laboratories Environment Testing, LLC. The Court finds that this purchase is for professional services and that the Commissioners Court may grant an exemption under Section 262.024, Local Government Code, from the competitive bidding requirements of Section 262.023, Local Government Code




