Judge Boedeker also addressed item CA63. He stated that on item CA63 there was a decrease in the dollar amount, the quote was originally \$102,177.00 for computer hardware, and the updated quote reduces the amount to \$97,425.00.

Judge Boedeker commented that both of the changes needed to be noted in the motion. He also noted that there were some additional documents to be signed regarding the follow-up contracts for the Oracle ERP System. He thanked the representative from Oracle, who flew in to oversee this, for being here and all the work they had put into getting them to this point.

Comm. Woolley stated that he would like to pull out Consent Agenda 59 for specific discussion.

Judge Boedeker called for a motion on the Consent Agenda and asked that the motion note the two changes to CA43 and CA63 and that it removes CA59, as they would take up CA59 separately.
