COUNTY OF JOHNSON

COMMISSIONERS COURT ORDER GRANTING AN EXEMPTION UNDER SECTION 262.024, LOCAL GOVERNMENT CODE, FROM THE BIDDING REQUIREMENTS OF SECTION 262.023, LOCAL GOVERNMENT CODE, UPON THE COMMISSIONERS COURT FINDING THAT A CONTRACT FOR JUDICIARY INTERPRETATION WITH GABRIELA LOMONACO IS A CONTRACT FOR PROFESSIONAL SERVICES

The Johnson County Commissioners Court met on October 28, 2024 in regular session for the consideration of a contract between Johnson County, Texas and Gabriela Lomonaco. The Commissioners Court finds that a contract for Judiciary Interpretation services with Gabriela Lomonaco is a contract for professional services and that the Commissioners Court may grant an exemption under Section 262.024, Local Government Code, from the competitive bidding requirements of Section 262.023, Local Government Code.


NOW THEREFORE BE IT ORDERED:

The Commissioners Court of Johnson County, Texas does hereby enter this Order granting an exemption under Section 262.024, Local Government Code, from the bidding requirements of Section 262.023, Local Government Code, upon the Commissioners Court finding that a contract for Judiciary Interpretation services with Gabriela Lomonaco is a contract for professional services.
