CALL TO ORDER

BE IT KNOWN that on the 28th day of October 2024, the Honorable Commissioners Court of Johnson County, Texas, met in Regular Session at the Johnson County Courthouse thereof, in the City of Cleburne, Johnson County, Texas, for the purpose of transacting any and all business that may lawfully be brought before the same. The meeting was called to order at 9:00 A.M. with all members present. The following items, having been lawfully posted and filed for record in the Office of the County Clerk on October 24, 2024, at 8:53 A.M., were considered:

PUBLIC ANNOUNCEMENTS

PA1. Announcements from County Commissioners Regarding County and Precinct Events

Comm. Woolley reminded the Court that today is National First Responder Appreciation Day and that we owe so much to our First Responders. He stated that The Catch restaurant in Burleson is donating a portion of its sales today to the Chisholm Trail 100 Club, which supports first responders and provides life insurance and other benefits for all of our first responders in Johnson, Hood, Somervell, and the City of Mansfield. Comm. Woolley stated that he wanted to highlight the Johnson County 4H Program and that they had a competitive team made up of 4 members of the Grandview 4H Club who were declared National Champions in the meat judging competition at the American Royal Show held at Kansas State University. He stated that the team members were Kade Davis, Jhett Davis, Brecken Shipman, and Harlie Groom, all from Grandview and coached by Justine Edrington. He stated that there has become quite a lengthy list of National Champion 4H teams from Johnson County, that they appreciate them, and that they need to give them a round of applause. He stated that he also wanted to cover the voting locations and that they are not voting at the Precinct 4 Office due to safety issues. He stated that they have such a small facility with no parking lot, trucks and heavy equipment go in and out all day with a single gate, and it has become a safety issue with the high voter turnout.

Comm. Bailey commented that the last election cycle ran three weeks because of COVID and the extra week in that last election cycle helped.

Comm. Howell added that there has been a huge turnout at the Burleson Sub-Courthouse and the parking lot, the grassy area, and both sides of the street, across from the high school, are full. He wanted to remind people that, during early voting, you can vote at any location such as the City of Godley in the Park Plaza.

Comm. Bailey stated that we have all grown accustomed to convenience but it is a good thing that this many people are voting.

Comm. White echoed Comm. Howell's statement and stated that Venus and Keene can get you in and out pretty fast. He stated that safety has been a big issue and Monday morning he called the Sheriff because people were parking along 917 because they were out of room. He added that it's a good problem.

Comm. Bailey stated that County Road 1205 is officially open and Old Foamy Road has been open for some time now. He added that County Road 1224 and County Road 1119 will soon be open.

IT Director Dan Milam stated that with 129,000 registered voters in Johnson County, over 40,000 people had cast their ballot in the first week of early voting.
