Agreement for Legacy Data Development and Migration and Statement of Work

1. Introduction

This section describes the Services that TodoVerde Technology Solutions will provide under this statement of work. Specifically, TodoVerde will provide Johnson County and other stakeholders with cloud data hosting and software development services resulting in a custom software interface to access and search data across legacy data sources.

This Agreement is subject to the provisions and limitations of TIPS Contract # 230504.

The investigation and the implementation of changes may result in modifications to the schedule of this SOW.



2. Assumptions

This SOW and TodoVerde's estimates to perform the SOW are based on the following assumptions.

- The custom software provided will run within a GCC (Government Community Cloud) CJIS compliant cloud environment.
- All data sources will be hosted and maintained within a GCC CJIS compliant cloud environment.
- Users of the application will have an internet connection.
- The custom software will integrate with SOMA Global line of products.

3. TodoVerde's Responsibilities

Design, development and implementation of custom software to search for and review legacy RMS data from various sources. Additional responsibilities include user documentation and personnel training on the new software functionality.

Tasks included in the design, development and implementation of new custom software:

Map Existing Database Schema

Task includes mapping multiple data schemas into a unified searchable database. Data conversion processes include but are not limited to the following RMS data sources:

- Central Square/OSSI
- Tyler Incode (on-premises database)
- ◆ CopSync
- ARMS
- Fundview

Application Development

The Legacy Data Search application shall allow individual agencies to search and extract reporting and other media from their legacy RMS data sources. High-level requirements and development tasks include:

- Secure user authentication and role-based access control
- Advanced search functionality
- Case detail viewing, including documents, images and or videos
- © Case reports for extraction of case details and court documentation

- Views for Arrests, Calls, Citations, Name, Property, Vehicle
- Sealing, expungement, and locking of individual case records
- Interagency case and historical data collaboration
- Integration with SOMA Global line of software products

Data Integration

The Legacy Data Search application will provide integration capabilities for outside vendors. Specifically, ODBC accessibility will be provided for SOMA Global to query and integrate data from legacy sources. In addition, an API will be provided for additional vendor integration soon.

4. Johnson County's Responsibilities

The responsibilities listed in this section are in addition to those responsibilities are to be provided at no charge to TodoVerde.

- Access and or approval for access of legacy data sources from outside vendors.
- User Acceptance Testing. Includes validation and verification of data aggregations, validation and verification of application functionality, and validation of functionality between user roles.

5. Project Management

Prior to the start of this SOW under the Agreement, the Customer will designate a person, called the Customer Project manager, to whom TodoVerde communications will be addressed and who has the authority to act for the Customer in all aspects of this Scope of Work. The Customer Project Manager's responsibilities include:

- Provide liaison between all project participants.
- Manage the Project Change Control Procedure for the Customer.
- Obtain and provide information, data, decisions, and approvals, within three (3) working days of TodoVerde's request unless the Customer and TodoVerde agree to an extended response time.
- Help resolve project issues and escalate issues within the Customer organization, as necessary.
- Permit posting of any notifications required by applicable law for Services provided at Customer locations.

6. Completion Criteria

TodoVerde shall have fulfilled its obligations under this SOW when the following occurs:

- Written confirmation from Project Manager that provided custom software fulfills customer requirements.

7. Pricing

- Development and migration to GCC cloud for repository and management will be a fixed cost for this SoW.
- Pricing includes hosting and management of legacy data in the cloud through Oct 31st of 2025

Total Fixed price for this SoW: \$185,051.10

8. Warranty

Custom software from TodoVerde is provided with a 12-month warranty from the time of production implementation.
