The meeting was called to order at 9:00 A.M. with all members present. # PUBLIC ANNOUNCEMENTS

PA1. Announcements from County Commissioners Regarding County and Precinct **Events** 

Comm. Bailey stated that the season of legislation is upon us. He said that it is going to be an interesting time with all the new members of the House and the Senate.

Comm. Woolley stated that he had two items of really great news. He stated that last week Attorney General Ken Paxton filed a lawsuit in Johnson County that he believes is in the 18<sup>th</sup> District Court against PFAS manufacturers. Comm. Woolley stated that this happened just a few days after the Texas Tribune article came out about our case here in Johnson County and that this hopefully will send a huge message to both members in the House and the Senate that this is something that needs to be looked at. He stated that they are already in litigation with the EPA but if they can get some legislative control over some testing then that leads into the next item of great news. He stated that they now have House Bill 1674, filed by representative-elect Kerwin, that very specifically and very thoroughly addresses testing of biosolids to be used for land application and that it gives levels of PFAS chemicals to be tested for. He added that it is on the Texas Leg website where you can look up House Bill 1674 and that Senator Sparks has already agreed to carry it on that side of the legislature. Comm. Woolley stated that it basically amends the agriculture code and that they are hoping for some positive results in this area. He stated that along with General Paxton's efforts, he thinks that our legislatures are getting the message that they will have to do something with this.

Judge Boedeker, along with the other Members of the Court, presented a Retirement Plaque to, Dale Hanna, Derrell McCravey, and Merry Cashion, District Attorney's Office for their years of service with Johnson County.

Comm. Woolley stepped out of the meeting at 9:23 A.M.

PA3. Presentation of the Annual Update for Texas A&M Agrilife Extension Service by Jay Kingston, District 8 Administrator; and Introduction of Cassandra (Cassie) Mavis, County Extension Agent, Agriculture & Natural Resources

Comm. Woolley returned to the meeting at 9:23 A.M.

Jay Kingston, District 8 Administrator presented the Annual Update for Texas A&M Agrilife Extension Service.

PA4. Update on Status of the Construction/Renovation of County Buildings by Joshua Green, Facilities Management Director

Facilities Management Director Joshua Green presented. He stated that the access controls for the Historic Courthouse should be completed by the end of next week and that they will have access and better ADA accessibility to this building.

Judge Boedeker stated, to remind the Court, that it was to add those handicapped buttons at the handicapped entrance of this building and upgrade some of the physical locks to the key fob locks. He stated that all the elected officials and department heads in the building have a meeting in a couple of weeks to sort out the details of who gets access and who needs access during what hours.

Comm. Woolley commented that it's great because he has always been concerned about the weight of even the upgraded doors that were redone. He said that they are still quite heavy and that he was convinced they might not meet ADA requirements.

Mr. Green stated that many other projects are going on but that the Fleet Maintenance Building is on schedule to be finished by the end of January.

Further discussion was held regarding the property on Harrell Street.
