This letter is respectfully submitted in compliance with the Health and Safety Code, Section 775.036 (a) (4) that each ESD Board should provide a written report no later than February 1 each year to Commissioners Court regarding the District's budget, tax rate and debt service.

ESD Annual Budget for FY 2024

Projected Revenue: Ad Valorem - \$7,334,887

Reserve Funds Special Projects - \$0

 SAUT Allocation from 2024 \$19,826,887

 Total Projected Revenue- \$27,161,174

 Projected Expenditures \$24,490,797.15

A large portion of the ESD budget is designated for distribution to the fire 15 departments, Medical Director and Emergency Support Services across the county, as they are the providers of fire protection, medical direction and scene rehab through contractual obligation with the ESD. As with any organization, personnel cost is also a large portion of the budget. The ESD's personnel costs include Administration, 24-hour operation of Dispatch, ESD Station 83 (Chisolm Trail) 24-hour staffing and ESD Station 82 (Lillian) staffed Monday through Friday, 7am to 7pm.

The ESD did exceed our no-new revenue rate; our no-new rate was \$0.052740/\$100 and we proposed and adopted a rate of \$0.054201/\$100 with a voter approval tax rate \$0.057514/\$100.

Our financial condition is excellent and we currently have no debt.

Thank you for your support and encouragement over the past year. The ESD appreciates its relationship with the Commissioners Court and will enhance that relationship in 2025. If there are any questions about anything within this letter, or anything else regarding the ESD operations and practices, please let me know. I will be glad to report to a Commissioners Court meeting, or meet individually to discuss your concerns.

On the 19th day of September 2024, be it known that the Board of Emergency Services Commissioners of Johnson County Emergency Services District No. 1 ("District") hereby adopted, by a majority vote of $\stackrel{\checkmark}{\perp}$ in favor, $\stackrel{}{\perp}$ against, $\stackrel{?}{0}$ present-not voting, and $\stackrel{?}{0}$ absent, the District's ad valorem tax rate for the 2024 tax year of \$0.057513 per \$100.00 valuation of the appraised property within the boundaries of the District, consisting of a separately adopted Debt Rate of \$0.002531 per \$100 valuation and a separately adopted Maintenance and Operations Rate of \$0.054982 per \$100 valuation. Per the Texas Tax Code § 26.05, all taxes raised by said Debt Rate and Maintenance & Operations rate of \$0.057513 will be used to fund the debt and maintenance and operations expenditures of the District for the next year.

THIS TAX RATE WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR'S TAX RATE.

JOHNSON COUNTY EMERGENCY SERVICES DISTRICT NO. 1 ADOPTED A TAX RATE THAT WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR'S TAX RATE.

THE TAX RATE WILL EFFECTIVELY BE RAISED BY 3.78 PERCENT AND WILL RAISE TAXES FOR MAINTENANCE AND OPERATIONS ON A \$100,000 HOME BY APPROXIMATELY \$0.78.
