## CALL TO ORDER

**BE IT KNOWN** that on the 10<sup>th</sup> day of February 2025, the Honorable Commissioners Court of Johnson County, Texas, met in Regular Session at the Johnson County Courthouse thereof, in the City of Cleburne, Johnson County, Texas, for the purpose of transacting any and all business that may lawfully be brought before the same. The meeting was called to order at 9:00 A.M. with all members present. The following items, having been lawfully posted and filed for record in the Office of the County Clerk on February 6, 2025, at 9:36 A.M., were considered:

## **PUBLIC ANNOUNCEMENTS**

PA1. Announcements from County Commissioners Regarding County and Precinct **Events** 

Comm. White stated that they had posted signs last week on one of his east-to-west thoroughfares in precinct three because they were going to tear the whole road up and it would be down all day. He stated that they planned it for tomorrow, but looking at the weather would need to bump it to next Tuesday. Comm. White noted for anyone who drives 528, between Renfro and 2738, that the road would not be passable as they had no choice but to shut the whole road down.

Comm. White continued and stated that there would be two, very important, Special Called Commissioners Court Meetings and urged any citizens who can attend to do so. He noted that the first meeting was the renaming of the 911 Call Center and that the center would be renamed after George Robinson, a deputy who was killed in 1971. Comm. White commented that he would let Comm. Woolley explain the second meeting, which was about biosolids, but he that he thought that it was very important for citizens to be involved in that also.

Judge Boedeker added that the first meeting, for the 911 Call Center, would be at 11:00 A.M. at the Sheriff's Office Complex, and the second meeting for biosolids would be back in the courtroom again.

Comm. White reiterated that he thought that both of them were important for citizens to see and be a part of.

Comm. Woolley stated that he posted the 2:00 P.M. Special Meeting regarding the Resolution on his social media platforms and that it has received about 19,000 views. He stated that there is a lot of interest in this topic and that he is looking forward to the continued discussion and updates during the meeting. Comm. Woolley continued and invited everyone, not just those from Johnson County but anyone from other counties that might be affected as well, to a town hall meeting at Chambers Creek Church, out east of Grandview on East FM 916, at 6:30 P.M. He stated that the meeting, hosted by himself, Detective Dana Ames, and Constable Fuller, was not only to bring the community up to date on the Resolution but also to provide background and the timeline of what has happened and what will happen in the future.

Comm. Woolley also commented that there were several Junior 4H and FFA Members who participated in the Fort Worth Livestock Show and that Mason Grady from Grandview exhibited the Grand Champion Hog. He stated that the Grady's hog brought about \$140,000.00 in the auction. Comm. Woolley commented that there are no caps on prices at the Fort Worth show so the winners get all the money. He also stated that he believed that there were at least six steer exhibitors in the sale Saturday and that when all the proceeds were added together, there was about a quarter of a million dollars, or \$300,000.00, in revenue generated by Johnson County kids. He commented that the Fort Worth economy is pretty good and the sale grossed a little over ten million dollars. Comm. Woolley congratulated Mason Grady and the other steer exhibitors and wished them luck in the upcoming shows.

Comm. Howell stated that he attended an event, For Liberty and Justice, Friday afternoon at Open Door Church. He commented that the group is basically like a prayer group for leaders and elected officials and that it honors them and tries to keep everyone on the right path. Comm. Howell stated that while at the meeting, he was asked to announce the 2:00 P.M. Special Called Meeting about biosolids, but that he did not have a lot of time to go into detail. He noted that several people spoke with him afterward and commented that they would try to be in attendance.

Comm. Bailey commented that he was expecting a courtroom full of folks at the biosolids meeting. He also stated that there were a couple of things going on in Austin last week, and while it was mainly related to school vouchers, Senator Hall had a couple of interesting bills. Comm. Bailey stated that the Senator had one bill that did not allow voters to go anywhere in the County and that they went by his office and gave their opinion on that. He stated that the Senator also had a bill regarding TCEQ and the notification to the Commissioners Court regarding mud districts. Comm. Bailey continued and stated that while there was the rhetoric with the tax-paid lobbyists, he felt the bigger concern they are facing is the Governor himself and his top 25 priorities. He stated that the Governor's proposal, regarding tax increases, would require counties to have a majority of two-thirds vote before any increases could be made and that this could be a huge concern for Johnson County one day. Comm. Bailey stated that it would probably be two or three weeks before they see those committees start to form. He said that they would be back in Austin to attend the CUC Conference going on this week. He added that when Comm. Woolley gets his agendas done tomorrow, he would be down Wednesday and Thursday.

Judge Boedeker thanked Comm. Bailey for representing Johnson County's citizens in Austin. He stated that he is usually pretty conservative and will hold his tongue when they are doing things in Austin because most things don't directly impact their voters and their citizens. But, he added, that if the Governor were able to, or if the legislature passed a revenue cap that limited the Court to zero increases, he thinks the citizens need to know the Court has been incredibly conservative with the budget for the last 40 years. He continued that, however, there are things that they need to pay for every year that are more expensive than they were the year before, and some of that's road materials and some of that's employees. Judge Boedeker stated that he hoped that everyone at every employer was able to receive some sort of cost of living increase. He commented that if the ability to increase revenues without a two-thirds election was taken away, none of their employees, like law enforcement, prosecutors, road crews, and all the people that keep the County functioning, are going to keep working here for what amounts to a pay cut year after year. Judge Boedeker stated that it could be the death of the county government as we know it in Texas, and it causes him to lose sleep at night.

Comm. Bailey stated that the State has responsibilities and obligations that they have to meet but that they have a surplus. He stated that the needs across the state are great, but that the priorities are different. He commented that he wished that the people from the capital could see Commissioners Courts in different counties across the state so that they could see how the Courts conduct business with what they have. Comm. Bailey stated Ms. Kerwin has hit the ground running with the biosolids issue, and had this Court not taken the steps that they did, the bill would not have been presented to the state. He also noted that that was also the case with the ambulance desert that is across the state.

Public Works Director Jennifer VanderLaan read a thank you letter from the Trinity River Authority of Texas to the Court.

PA2. Update on Status of the Construction/Renovation of County Buildings by Joshua Green, Facilities Management Director

Facilities Management Director Joshua Green presented. He stated that over at the Guinn Justice Center, the chimney restoration is going well with a little weather interference, but hopefully they will be wrapped up this week. He commented that they had hoped they would have gotten done last week, however, there were a few items that they had to address. He added that as well as the parapet wall going over, Prime Source is actively working on that to get the Duro-Last material up and over the wall there, so they can avoid any potential leaks and clean up the ones that they currently have. Mr. Green said that here at the Courthouse, the door access was provided an update Friday and that they are still waiting on the manufacturer to design or make a bracket for them. He added that they are still waiting on that to get this building fully access-controlled. He stated that the fleet maintenance building is going according to schedule and looking great and that he can give anyone a tour at any time.

Judge Boedeker drew the Court's attention to CA36 and stated that this was an item that had come up once about three years ago, where if a local fire department wants to borrow money to buy a fire apparatus, they need a letter of support or consent from a local governing body and that would be them. He stated that it is not a guarantee of the loan and it is not them being involved in their debt process and that County Attorney Bill Moore looked this up and helped walk them through the process, and they appreciate the assistance from Mr. Moore. He added that he just wanted to bring that to everyone's attention, that there is a representative from Bono here as well, and that they are looking forward to buying a new fire truck and putting it into service.

Comm. Woolley commented that there was an item he wanted to point out.

While Comm. Woolley was looking for his item, Judge Boedeker added to anyone who was listening that he wanted to draw attention to the fact that there are about half a dozen items that are election equipment leases with local entities. He stated that their elections office strives to partner with local cities and school districts to help conduct their elections. He stated that they conduct those elections on behalf of outside entities, and for the elections that they do their own, they frequently lease out their equipment to them at a very low cost so that they have modern, compliant election equipment for elections that might yield 20 or 30 votes. He added that it wouldn't make sense for them to go out and buy a \$5,000.00 or \$10,000.00 machine to count ballot, but that it keeps them ADA compliant and that they strive to partner with their local cities to save money for taxpayers.

Comm. Bailey agreed and stated that this is why they need to have early voting and different polling locations.

Comm. Woolley stated that he found what he was looking for, which was item CA22. He commented that if he was not mistaken, this was a mud district that was going to be located just north and east of Grandview. He stated that there had been a legal notice in the newspaper, and he is guessing this is the acknowledgment of that, and he asked Mrs. VanderLaan if that was correct.

Mrs. VanderLaan replied with a yes.

Comm. Woolley stated that to this date, other than this receipt of application, there has been no communication at all with his office, the County Judge's office, or the Public Works office. He stated that there are several hundred acres in there and that there are almost a million gallons a day that are discharged, 950,000 gallons a day is what this permit is for. He asked Mrs. VanderLaan if they were going the TCEQ route.

Mrs. VanderLaan responded that she believed that they were looking for legislation to support the approval of their district and then the TCEQ permitting process for the wastewater treatment plant.

Comm. Woolley stated that he has a meeting scheduled with Senator King's Office next Thursday and that he will express concern about this. He said that it is a million gallons a day that is just going to free flow and eventually go into Chambers Creek. He added that they have already established that Chambers Creek is potentially contaminated with their biosolids issue, that this is not a healthy situation, and that some residents in his precinct are pretty upset about it. He reiterated that he wanted to point that out and that it is just an acknowledgment and not an approval and that so far, they have had zero communication between the County and these applicants.

Comm. Bailey acknowledged that CA18, CA19, and CA20 have to do with cement plants and that for whoever is listening, we are a nonattainment county and that they are grouped in with a few and it generally has to do with prevailing winds due to the cement plant in Midlothian. He added that at the COG, they got a notice from TCEQ that if they do not meet air quality standards in this region by 2030, this region would no longer receive federal dollars, and that is from TCEQ telling them that they need to meet standards.

Comm. Woolley asked Comm. Bailey if he would repeat that.

Comm. Bailey stated that if they do not meet the air quality standards in this region by 2030, they would no longer be eligible for federal dollars coming into this north central Texas COG. He said that TCEQ had sent them this letter, but yet TCEQ continues to add fuel to the fire. Furthermore, methane gas from landfills and bio-farming, any of that, is not part of that equation, and it has to do with emissions in cement. He added that there are three more to go with that list and that the lime plant in Clifton has been applied for, basically doubling the size of that facility there. He stated that he wanted to be on the record here and at the COG to contest TCEQ's double standards. He noted that if they don't meet the guidelines, then they will be penalized and that he wanted the Court to understand. Comm. Bailey added that they just passed a huge transportation bond that will require state, local, and federal dollars. He stated that he had sent letters and that everyone needed to get behind this, and that when he saw this, it was unimaginable that this was going to continue and that he wanted to put that out there.
