ORDER ADOPTING A NAME CHANGE FOR A PORTION OF COUNTY ROAD 905

WHEREAS, Texas Transportation Code *Section 251.013* allows a county by order to adopt a name for a public road in the unincorporated area of the county; and

WHEREAS, County Road 905 (CR 905) is located in the unincorporated area of Johnson County; and

WHEREAS, notice of a public hearing to consider the name change of a portion of CR 905 was published in a newspaper of general circulation prior to the date of the meeting at which this Order was adopted; and

WHEREAS, a portion of CR 905 adjacent to the subdivision known as Silo Mills will be improved and widened from the intersection of CR 905 with CR 1010 and continuing north approximately 1100 feet to the point where CR 905 makes a ninety (90) degree eastward turn; and

WHEREAS, the developer of Silo Mills is requesting that the portion of CR 905 being improved be re-named as Silo Mills Parkway.

NOW THEREFORE BE IT ORDERED, The Commissioners Court of Johnson County, Texas hereby enters this Order Adopting a Name Change for a Portion of County Road 905 to change the name of the portion of CR 905 from the intersection with CR 1010 and continuing north approximately 1100 feet to the point where CR 905 makes a ninety (90) degree eastward turn as Silo Mills Parkway.

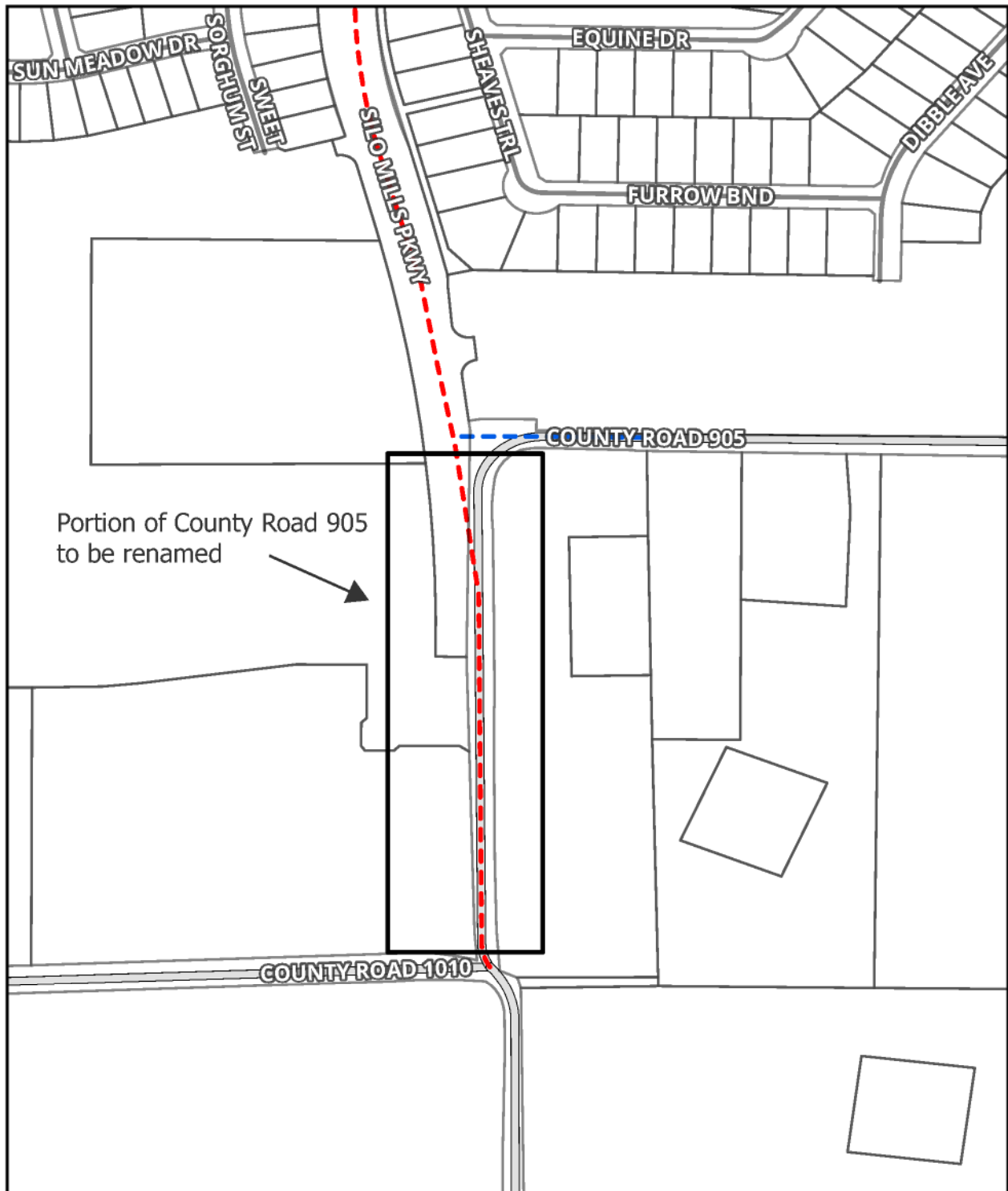
