CALL TO ORDER

BE IT KNOWN that on the 10th day of March 2025, the Honorable Commissioners Court of Johnson County, Texas, met in Regular Session at the Johnson County Courthouse thereof, in the City of Cleburne, Johnson County, Texas, for the purpose of transacting any and all business that may lawfully be brought before the same. The meeting was called to order at 9:00 A.M. with all members present. The following items, having been lawfully posted and filed for record in the Office of the County Clerk on March 5, 2025, at 11:06 A.M., were considered:

Judge Boedeker stated for the record that all the Members of the Commissioners Court were present as well as other department heads and elected officials necessary for today's meeting.

PUBLIC ANNOUNCEMENTS

PA1. Announcements from County Commissioners Regarding County and Precinct Events

Comm. Bailey stated that he wanted to recognize a legend that they lost in our county. He said that Howard Dudley passed on Friday and that it is a huge loss to the community and humanity. He added that he was a humble man, left behind a huge legacy, and was a big employer in this area. Comm. Bailey stated that everywhere he had gone that he improved things and that Southlake would not be what it was today without his presence. He added that a lot of the amenities that they have in downtown like the Hospital, Hill College, the Welding shop, as well as the new football field in Blum was because of his charity. He said that he was a good friend of his and a good friend of this community. Comm. Bailey asked the Court to take a moment of silence in his memory.

Judge Boedeker thanked Comm. Bailey and added that it was hard to walk downtown and not see his influence on everything.

Comm. Bailey agreed and stated that Howard Dudley would be missed. He said that, on the home front, the committees are lined up in Austin and there is much uncertainty. He added that the bill they introduced, Bill 239, was moved ahead of everything else and became Senate Bill 19. He stated that he gave his testimony on behalf of the Judges and Commissioners Association to reserve their right for representation for counties their size. He added that their contribution to that association was \$3,500.00 and that the Association was under the knife. He said that hopefully they can reach the new members and educate them. He added that the goal was to knock on all the doors, not only on this issue but many others. He stated that the PFAS bill is getting attention. He added that he had spoken to Judge Little in Ellis County, who had been to DC, and that the PFAS issue was the talk of DC. He said that they owe much gratitude to Judge Little and that they will be in Austin together this week. He added that Ellis County has many similar issues as Johnson County. Comm. Bailey encouraged the Court and the public to let Austin hear from them.

Comm. Woolley stated that he wanted to make the Court aware of things that are happening outside of state lines due to Johnson County's action regarding PFAS contamination and land application. He stated that prior to their February 16, 2024 meeting where Detective Ames presented her findings, there had only been one state that took action similar to Johnson County, which was the State of Maine back in 2021. Comm. Woolley said that since the February 24th meeting and with all the media attention, several states have followed their lead, including Connecticut, New York, Minnesota, and Michigan. He added that other states are working on getting legislation, including Wisconsin, Maryland, Vermont, Indiana, Oklahoma, Hawaii, and Colorado. He said that there are local authorities, as well, who have bans on PFAS, such as Plainfield Township in Pennsylvania, Bethlehem, New York, and Albany County, New York. He added that if it wasn't for this Commissioners Court, none of this would be happening nationwide. He said that the other Texas counties that have done resolutions were Ellis, Henderson, Kaufman, Somervell, Wise, Franklin, Hood, and Hunt. He stated that soon there will be over a dozen counties in the state that are requesting something be done about these chemicals. He said that the resolution does not call for the banning of biosolids, but it calls for the testing of PFAS chemicals in biosolids to determine if the levels are harmful. He reiterated that they are not asking for a ban, just regulation and he wanted to make the Court aware of the impact that this has made on other states. He stated that such a nationwide impact would be hard for the legislature to ignore.

Comm. Bailey stated that it would be interesting to find out what the states that have banned this do and what their mode of transportation is.

Comm. Woolley replied that if they test above certain limits that they have to be incinerated or put in a landfill. He added that the PFAS testing the county did was money well spent.

Comm. Bailey echoed Comm. Woolley's statements and stated that none of them wanted to find this but that it was the right thing to do.

PA2. Update on Status of the Construction/Renovation of County Buildings by Joshua Green, Facilities Management Director

Facilities Management Director Joshua Green presented. He stated that it was going to be a busy week for Facilities Management. He said that his team was currently on the roofs, checking everything and that there was still a little bit of ice left on the Historic Courthouse roof from the hailstorm. He added that they have reached out to contractors and that they are going to get with the insurance. He said that since they are new roofs he is hoping they didn't sustain too much damage. Mr. Green said that they are working on getting the CO for the Fleet Maintenance Building and that they hope to be done by the end of the week. He said that the parapet wall at the Guinn Justice Center was completed Friday night right before the storm blew through Saturday morning. He stated that they would get their adjusters out to make sure there was not too much damage.

Comm. Woolley asked Mr. Green about the lighting situation at the extension parking lot.

Mr. Green replied that two street lights were out but that they had been fixed and that they had requested pricing for some parking lot lights.

Comm. Woolley asked if those street lights were city lights.

Mr. Green replied with a yes.
