ORDER 2025-28

COMMISSIONERS COURT GRANTING AN EXEMPTION UNDER SECTION 262.024, LOCAL GOVERNMENT CODE, FROM THE BIDDING REQUIREMENTS OF SECTION 262.023, LOCAL GOVERNMENT CODE, UPON THE COMMISSIONERS COURT FINDING THAT GOVOS PROVIDES A PRODUCT AND SERVICE THAT CAN BE OBTAINED FROM ONLY ONE SOURCE

The Johnson County Commissioners Court met on **April 14, 2025**, in regular session for the consideration that the Real Property and Vital Statistics software used by the County Clerk are a product and service that can be obtained from only one source. The Commissioners Court finds that the Commissioners Court Minutes (CCM) Upload Module (software) is a product and service that integrates with other software from GovOS in use by the County and that can be obtained from only one source, which is GovOS, Inc., and that the Commissioners Court may grant an exemption under Section 262.024, Local Government Code, from the competitive bidding requirements of Section 262.023, Local Government Code as no other company provides the said product or service in Johnson County, Texas.

NOW THEREFORE BE IT ORDERED, The Commissioners Court of Johnson County, Texas does hereby enter this order granting an exemption under Section 262.024, Local Government Code, from the bidding requirements of Section 262.023, Local Government Code, upon the Commissioners Court finding that the Commissioners Court Minutes (CCM) Upload Module (software) is a product that integrates with other software from GovOS in use by the County and that product can be obtained from only one source which is GovOS, Inc.


The following are the sole source reason(s) for the Sole Source Products:
