- 2. A photograph of each item shall be attached to its Memorandum of Donation form.
- 3. Age, historic significance (especially to Johnson County, Texas) and rarity of the proposed donation(s) shall be considered by JCHC on an individual basis.
- 4. Large items or items requiring special handling or storage cannot be accepted at this time.
- 5. JCHC reserves the right to decline any donation. If not accepted by JCHC, Donor has thirty (30) days to retrieve their item(s). After 30 days, disposition shall be at the discretion of JCHC Executive Committee.
