VENDING SERVICE AGREEMENT

This AGREEMENT is made the <u>28th</u> day of <u>April 2025</u> by and between: <u>JOHNSON COUNTY</u> (Customer) and <u>SPG VENDING SOLUTIONS, INC.</u> (Vendor)

WHEREAS Customer desires quality vending service for its employees and visitors to its premises.

WHEREAS, Vendor has the capacity and the knowledge to provide vending products and services to meet Customer's needs.

NOW, THEREFORE, both parties agree as follows:

- Customer grants to Vendor the exclusive right to provide vending and coffee services, including, without limitation, vending machines for drinks and snacks, kiosks, mini-marts or convenient store style vending upon Customer's business premises subject to the terms and conditions of this AGREEMENT.
- 2. The initial term of the AGREEMENT shall commence on <u>April 28th</u>, 2025 and shall continue until <u>April 28</u>, 2028. Following the expiration of this initial term, the Customer will have the option of (4) four (1) one-year contract renewals. The Customer is willing to consider other vendor proposals for terms indicated. Any additional terms vendor recommends that might be beneficial to Customer. The AGREEMENT may be terminated upon expiration of the AGREEMENT with notice in writing tendered (30) thirty days prior to the expiration of the AGREEMENT or any subsequent renewal thereof;
- 3. Vendor shall be responsible for installing and maintaining vendor equipment which reasonably meets Customer's needs. Customer shall provide all utilities, including necessary water, electrical lines, and internet lines and service. Customer shall also dedicate appropriate space for Vendor's equipment which is designated to maximize access to the vending mechanism, whether units, kiosks or other equipment, by both their users and by employees or agents of Vendor who services the vending equipment.
- 4. If Customer is dissatisfied with Vendor's service, Customer is to inform Vendor in writing. The vendor will have (30) thirty days to rectify the problem addressed. If the problem is not resolved by both Customer and Vendor's satisfaction within the (30) thirty days, Customer may serve a (30) thirty-day notice of intent to cancel AGREEMENT with the Vendor.
- Customer recognizes that Vendor will invest significant sums of money on equipment and service in reliance to Customer's promise of exclusivity which is the key element of this AGREEMENT;
- 6. Vendor will provide Customer with 21% commission; paid on a monthly basis.
- 7. This AGREEMENT is assignable by Vendor without notice;

This AGREEMENT automatically transfers to new management, property managers, and/or buyer as well as any subsequent changes in address and/or business name changes.
