1. Scope of Services

SCOPE OF WORK

PEST CONTROL SERVICE – Johnson County Facilities Management Johnson County Facilities Management (JCFM) The contractor shall provide coverage of all JCFM Facilities listed below. The service area consists of eighteen (18) buildings totaling roughly 440,000 sq. ft.

CALLS FOR SERVICE:

The contractor shall respond only to calls for services placed by Johnson County Facilities Management personnel, consisting of: Office Manager, Director, Assistant Director, Custodial Supervisor

REQUIRED TASKS

Inspecting and controlling all vermin, such as, but not restricted to: rats, mice, roaches, bedbugs, fleas, stinkbugs, ants, wasp, bees etc.

Spraying of all building exteriors, hallways, offices, common areas, bathrooms, and holding cells monthly. Requirements listed in the Services section below.

DESCRIPTION/SPECIFICATIONS/WORK STATEMENTS

General:

The contractor shall provide all supplies, materials, equipment, labor, supervision, management, and transportation to perform all tasks as identified. All work is to be performed during normal business hours. The contractor must be accompanied by a member of JCFM while conducting service and must call 30 minutes prior to arrival.

Scheduling:

Pest Control services shall be scheduled on definite appointed days and in no event shall the contractor carry on work outside regular agreed-upon working hours without prior approval from JCFM. Business hours are Monday-Friday 8am to 5pm.

Services required of the contractor are as follows (MONTHLY/AS NEEDED):

General structural anthropoid pests (i.e., cockroaches, ants, carpet beetles, spiders, carpenter ants, etc.). MONTHLY

Flying insect pests (i.e., house flies, stable flies, fruit flies, blow flies, etc.). MONTHLY

Bait Boxes (mice & rats) INSPECTED/MAINTAINED MONTHLY

Predatory pests (i.e., bedbugs, fleas, mites, ticks, bees, wasps, mosquitoes, etc.). AS NEEDED

Skunks, raccoons, and stray cats. AS NEEDED

2. Term

This Agreement shall begin on 05/12/2025 and remain in effect for an initial term of one year. Thereafter, it shall automatically renew for up to four additional one-year terms at Johnson County's sole discretion, unless terminated earlier in accordance with Section 6.

3. Compensation

The Client agrees to pay the Contractor in accordance with the rates outlined in **Exhibit A**. Invoices will be submitted monthly, and payment is due within [45] days of receipt.

4. Client Obligations

The Client agrees to:

Provide reasonable access to the premises during scheduled service times. Notify the Contractor of any known pest issues requiring urgent attention.

5. Compliance and Safety

The Contractor shall comply with all applicable federal, state, and local laws and regulations governing pest control operations, and shall use only legally approved and properly labeled products.

6. Termination

Either party may terminate this Agreement with **30 days' written notice**. In the event of termination, the Client shall pay for all services rendered up to the date of termination.

7. Insurance

The Contractor shall maintain liability insurance and workers compensation insurance as outlined in RFP 2025-301 and provide proof upon request.

8. Entire Agreement

This Agreement, including Exhibit A and all terms and conditions contained in RFP 2025-303 constitutes the entire agreement between the parties and supersedes any prior understandings or agreements.
