CALL TO ORDER

BE IT KNOWN that on the 28th day of April 2025, the Honorable Commissioners Court of Johnson County, Texas, met in Regular Session at the Johnson County Courthouse thereof, in the City of Cleburne, Johnson County, Texas, for the purpose of transacting any and all business that may lawfully be brought before the same. The meeting was called to order at 9:00 A.M. with all members present. The following items, having been lawfully posted and filed for record in the Office of the County Clerk on April 24, 2025, at 8:42 A.M., were considered:

Judge Boedeker stated for the record that all the Members of the Commissioners Court were present, as well as other department heads and elected officials necessary for today's business.

PUBLIC ANNOUNCEMENTS

PA1. Announcements from County Commissioners Regarding County and Precinct Events

Comm. Bailey stated that the tire collection event started this weekend and that they collected 907 tires on Saturday. He said that people were still calling on Saturday after the event, and that he assumes they will be collecting more this morning. He stated that it appeared to be another successful event. He added that he reached out to Mr. Blankenship to make sure there was law enforcement coverage, and he encouraged the other Commissioners to do the same.

Comm. Howell thanked Comm. Bailey for the information and stated that Precinct 2 was next for the tire collection event. He stated that they would request 3 or 4 officers. He said that last year was a learning experience, but that he thinks they have it down now. He added that Precinct 2 starts this Saturday.

Comm. Bailey gave a shout-out to their State Rep, Mrs. Kerwin, and her success getting bills pushed through in Austin. He added that there is a hearing on House Bill 5332 regarding overweight vehicles and that they will have to see how that plays out.

Judge Boedeker thanked Comm Bailey's efforts and for being in Austin. He said that it is great to have a voice in Austin. He thanked both Comm. Woolley and Comm. Bailey for being down there, going above and beyond, and making sure Johnson County doesn't get left out of the process.

Comm. Bailey thanked Judge Boedeker and stated that it is important that they have a voice in Austin.

Comm. Woolley stated that he has been in Austin for the last two weeks and that last Monday, he testified on House Bill 3087, which originated in Johnson County. He added that it was a request to the State to allow counties to have the ordinance ability to establish child safety zones in the unincorporated part of the county. He said that they had good representation from Johnson County. He stated that they are hoping to get a hearing on House Bill 1674, which is regarding the PFAS regulations, and that they have 76 coauthors in the House, and he said that sends a big message. He added that, as Comm. Bailey said, they are at the end of the session, and if they don't get it done this session that they will do it in the next session.

Sheriff Adam King asked Judge Boedeker if he could share something.

Judge Boedeker said absolutely.

Sheriff King stated that a woman came up to him and showed him a 15-year chip of her being clean and sober, and that he wanted to celebrate that as she was here today in the audience.

Judge Boedeker thanked Sheriff King for sharing and said that it was wonderful news.

Judge Boedeker asked when the tire collection dates were for Pct. 3 and Pct. 4.

Comm. White replied that Pct. 3 starts on the 10th and then on Monday, Tuesday, and Wednesday, after that.

Comm. Wooley stated that in Pct. 4, it started on the 17th.

PA2. Presentation of Proclamation "Soil and Water Stewardship Week" with Paula Burgess, Johnson County Soil and Water Conservation District

Judge Boedeker read the "Soil and Water Stewardship Week" Proclamation, and he, along with other Members of the Court, presented the proclamation to the Johnson County Soil and Water Conservation District and other representatives.

PA3. Presentation of Proclamation “Mental Health Awareness Month and Children’s Mental Health Awareness Day” with Celia Brannon, Mental Health Advocacy Partners

Judge Boedeker read the “Mental Health Awareness Month and Children’s Mental Health Awareness Day” Proclamation, and he, along with other Members of the Court, presented the proclamation to Celia Brannon, Mental Health Advocacy Partners, and other representatives.

Comm. Woolley stepped out of the meeting at 9:27 A.M.

PA4. Update on Status of Major Transportation and Development Projects by Jennifer VanderLaan, Public Works Director

Comm. Woolley returned to the meeting at 9:28 A.M.

Public Works Director Jennifer VanderLaan presented. She said that Public Works has been involved in many different projects, specifically transportation projects. She stated that they recently adopted the Major Thoroughfare Plan and that the final invoice for that project has been received. She added that the bond program is moving forward with contract negotiations for a program manager. Mrs. VanderLaan added that the COG has received a yes vote from the Surface Transportation Committee to allocate 20 million dollars to one of the projects listed out of the 16 that were selected, and they will receive that funding. She said that Freese and Nichols had requested the ability to nominate Johnson County for the Major Thoroughfare Plan and the bond program to be considered for an award by the Texas chapter of the American Planning Association at its annual conference in October. She added that they are currently collecting letters of support for that nomination and that it is very exciting for the county to receive an award for those projects. Mrs. VanderLaan stated that, as some of the Commissioners had already mentioned, there is legislation that will affect some of their authority, which is Senate Bill 2522, and it is being heard today in local government. She added that the bill is regarding the regulation of platting and subdivisions of land, and that what they can do after this session remains to be seen. She said that in the meantime, Public Works, along with the Engineering Department and the County Attorney’s Office, continue to move forward with some inspiring projects. Mrs. VanderLaan commented that permits are up by 40 more permits a month compared to the first 6 months of the last fiscal year, which equals about \$20,000.00 extra in fees each month on average.

Judge Boedeker asked Mrs. VanderLaan if that was on septic and development.

Mrs. VanderLaan replied with a yes.

Further discussion was held on bills in Austin regarding local authority.
