COMMISSIONERS COURT GRANTING AN EXEMPTION UNDER SECTION 262.024, LOCAL GOVERNMENT CODE, FROM THE BIDDING REQUIREMENTS OF SECTION 262.023, LOCAL GOVERNMENT CODE, UPON THE COMMISSIONERS COURT FINDING THAT BOK FINANCIAL SECURITIES, INC. AND STEPHENS, INC. AS UNDERWRITERS FOR THE SALE OF JOHNSON COUNTY, TEXAS UNLIMITED TAX ROAD BONDS, SERIES 2025, ARE PROVIDING A PROFESSIONAL SERVICE.
