PARTICIPATION FOR COUNTY ROAD EXPANSION

KNOW ALL MEN BY THESE PRESENTS:

Comes now Cresson Ventures LLC., hereafter known as "Participant" and Johnson County, Texas, hereafter known as "Johnson County".

Whereas Participant is developing property in Johnson County, Texas that requires certain road characteristics including paving approximately one mile of County Road 1000 and installing a turn lane near Ace High Lane, in Johnson County, Texas (collectively, "Public Improvements"); and

Whereas Johnson County is a political subdivision of the State of Texas which maintains certain roads within Johnson County; and

Whereas Johnson County has limited resources for the expansion and improvements of such roads; and

Whereas Johnson County is authorized to act and does act as shown by signature below, by and through the Commissioners Court of Johnson County, pursuant to V.T.C.A., Local Government Code Section 81.032 and V.T.C.A., Transportation Code Section 252.214 to accept the Public Improvements provided by way of Participant, contracting for the construction of the Public Improvements.

THEREFORE:

Participant intends to contract with one or more construction companies approved by the Commissioner of Precinct No. 2, Kenny Howell, to construct the Public Improvements shown in the attached Exhibit A.


The above-described action, subsequent to being offered, is subject to acceptance and approval by the Commissioners Court of Johnson County in an open session of the Commissioners Court of Johnson County.

Participant, by executing this Participation for construction of the Public Improvements understands that, upon completion and acceptance by Johnson County, it will transfer ownership of the Public Improvements to Johnson County and ensure the payment of funds due and owed to its construction companies as described, with the understanding Participant's portion of the costs for the Public Improvements will not exceed the amount required for the Public Improvements that are roughly proportionate to the proposed development per Section 232.110 of the Texas Local Government Code.

Participant understands this is a nonbinding memorialization of Participant's intent to provide for the construction and payment of the Public Improvements and this neither creates a binding contract nor any obligations on the part of Participant.
