The meeting was called to order at 9:00 A.M. with all members present except for Comm. Woolley, Pct. 4. Judge Boedeker stated for the record that all the Members of the Commissioners Court were present, except for Comm. Woolley, who was unavailable today, as well as other elected officials and department heads necessary for today's meeting.

#### **PUBLIC ANNOUNCEMENTS**

PA1. Announcements from County Commissioners Regarding County and Precinct **Events** 

Comm. White commented that this is the time of year when roads are being worked on and that one of his employees almost got run over. He added that all of his employees have families and that they are just trying to do their jobs, and for the public to be careful.

Comm. Bailey echoed Comm. White's comments and stated that they are just trying to take care of business. He stated that it is a fast-paced world, and there is a lot of impatience that comes with that.

Comm. White thanked the Sheriff's Office and stated that they found the man who almost ran over one of his employees.

Comm. Bailey stated that people have also been frustrated with the high waters due to all of the rain. He stated to be careful out there, that they have crews out checking the high-water gates, and that it is an unusual July.

Comm. Howell added to Comm. White's comments and stated that they are trying to save people from themselves from driving through the high waters. He asked the public if there is a barricade up, not to cross it.

Judge Boedeker stated that Jamie Moore reached out to him, saying he was working the scene and that he wanted to remind everybody that the closed roads do get posted to his Facebook page. Judge Boedeker urged the public to check the Emergency Management page for any closures. He also recommended that people get a cheap weather radio.

Employees of Johnson County were recognized for their service to Johnson County, and employees were given service pins, as attached to these minutes.

Comm. White stated for the record that it was a total of 110 years of service.
