COMMISSIONERS COURT GRANTING AN EXEMPTION UNDER SECTION 262.024, LOCAL GOVERNMENT CODE, FROM THE BIDDING REQUIREMENTS OF SECTION 262.023, LOCAL GOVERNMENT CODE, UPON THE COMMISSIONERS COURT FINDING THAT SCHINDLER ELEVATOR CORPORATION PROVIDES A PRODUCT AND SERVICE THAT CAN BE OBTAINED FROM ONLY ONE SOURCE

The Johnson County Commissioners Court met on July 14, 2025, in regular session for the consideration that Schindler Elevator Corporation provides a product and service for the elevator at the Johnson County Historical Courthouse that can be obtained from only one source due to proprietary parts, specialized diagnostic tools, and technician certification requirements. The Commissioners Court finds that Schindler Elevator Corporation provides a product and service for the elevator at the Johnson County Historical Courthouse that can obtained from only one source, and that the Commissioners Court may grant an exemption under Section 262.024, Local Government Code, from the competitive bidding requirements of Section 262.023, Local Government Code as no other company provides said product and service in Johnson County, Texas.

NOW THEREFORE BE IT ORDERED:

The Commissioners Court of Johnson County, Texas does hereby enter this order granting an exemption under Section 262.024, Local Government Code, from the bidding requirements of Section 262.023, Local Government Code, upon the Commissioners Court finding that Schindler Elevator Corporation provides a product and service for the elevator at the Johnson County Historical Courthouse that can be obtained from only one source.
