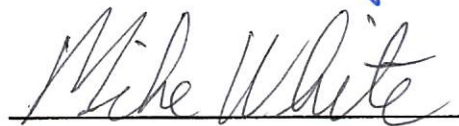

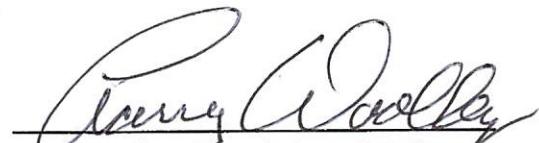

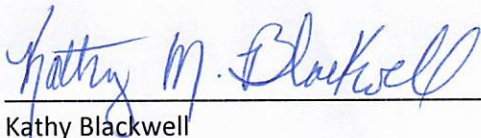


Summary

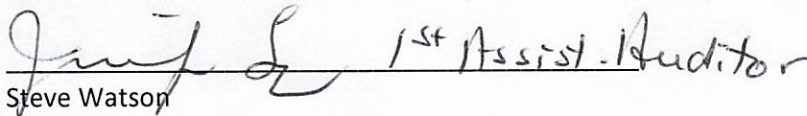
