Hi Roxann,

Thank you for reaching out to us and we'd be happy to help y'all with your employee. We start a new class every Monday, so depending on how soon you want to get them started, we can get going Monday October 6th with a tentative graduation date of October 31st. All of our testing takes place on site (Permit and CDL), so it saves so much time during the program. The full cost of the tuition would be \$5,200. \$5,000 for the course and \$200 for the Tanker endorsement. The only thing that's not included within that total is \$75-\$95, this is the DPS fee. After our students graduate and pass we make them an appt at the DPS to process their CDL and take their picture. We don't know that actual amount, so we don't include it.
