ADDENDUM

Commitment to Compliance – Texas Administrative Code, Chapter 358

This Addendum is part of an Agreement made between Johnson County Juvenile Services and **Shoreline Treatment Center**, hereinafter known as CONTRACTOR. The primary Agreement is identified as: **Residential Services Contract**. This Addendum is being incorporated into said Agreement for all purposes. "Johnson County" or "County" as used herein shall be deemed to include or mean Johnson County Juvenile Services where appropriate or where necessary to give meaning to the Agreement.

In alignment with state requirements and agency standards, Shoreline Treatment Center affirms its Commitment to Compliance with the provisions outlined in the Texas Administrative Code, Chapter 358.

Parties agree to abide by the provisions of Title 37, Chapter 358 of the Texas Administrative Code regarding Identifying, Reporting, and Investigating Abuse, Neglect, Exploitation, Death and Serious Incidents. As the Contractor is a Non-Juvenile Justice Contract facility, the Contractor shall comply with all requirements of 37 TAC 358.200 as follows:

- (1) Contractor shall report any and all allegations of abuse, neglect, exploitation, the death of a juvenile, or a serious incident to local law enforcement, Johnson County and to the Texas Juvenile Justice Department (TJJD) in accordance with this chapter;
- (2) Contractor shall conduct an internal investigation or allow Johnson County to conduct an investigation and to cooperate with such investigation; and
- (3) Contractor shall cooperate with TJJD during any assessment or investigation.

In the event of any conflict between either the terms and provisions of this Addendum and the terms and provisions of those contractual provisions tendered to Johnson County, this Addendum shall control.
