BE IT RESOLVED by the Commissioners Court of Johnson County, Texas, that any person desiring to cross any hard-topped County Road with an underground pipe, line, cable, equipment, etc. shall be required to obtain a permit from the County Judge's Office before making any excavation;

Said permit shall provide whether work will be done by tunneling under road or by cutting through the hard surface with a ditch. No charge shall be made for permit to tunnel under hard-surfaced road.

Those persons desiring to make a cut through hard-surfaced roads maintained by Johnson County will pay to the County Treasurer on the following scale:

Excavations four inches wide and less - \$35.00. Cuts more than four inches wide and up to and including 12 inches - \$50.00. Over 12 inches wide and up to and including 18 inches - \$100.00. Over 18 inches wide - \$150.00. The person making the cut will backfill the ditch and tamp it. In payment of the above sum, Johnson County will accept the future maintenance on this excavation, as well as the repair of the hard surface by concrete and asphalt.

A motion was made by Commissioner Roland and seconded by Commissioner Bryant that the following Resolution be accepted.

BE IT RESOLVED by the Commissioners Court that Louis B. Lee is appointed the alternative representative to the North Central Texas Council of Governments to act in all official meetings of its Board of Directors or in any other action of the North Central Texas Council of Governments when the regular representative, County Judge Herschel C. Winn, is unavailable to so act.
