PETITION TO DISCONTINUE PUBLIC ROADS AND ALLEYS

Now comes the undersigned freeholders of Johnson County, Texas, who reside in the vicinity of what is known as the Town of Parker, and file this their petition to discontinue public roads and alleys situated in the Town of Parker, Johnson County, Texas, and would show the Honorable Commissioners' Court as follows:

1.

On June 10, 1903, M.L. Kennard conveyed to William Malone, Trustee, by deed of record in Vol. 110, page 199, Deed Records of Johnson County, Texas, a tract of land which a part of the Town of Parker is now situated on; that in this instrument there is language to the effect that the grantee will divide the property into "lots, streets and alleys" and said property is to become a part" of the town of Osceola." That said property was divided into "lots, streets and alleys" and a plat of the said division is of record in Vol. 112, page 639, Deed Records of Johnson County, Texas.

2.

Your applicants would show the Court that the below described streets and alleys have been under fence for numerous years, and have not been used by the public for the purpose for which they were dedicated.

Your applicants would request that the Commissioners' Court enter an order discontinuing and closing the following described streets and alleys, and portions thereof:

- (a) A portion of Wilson Street which divides Block 7 and 8, according to the plat of record in Vo. 112, page 639, Deed Records of Johnson County, Texas, and being all that certain lot, tract or parcel of land out of the Ralph Tandy Survey, Patent No. 454, Vol. 7,
