A motion was made by Commissioner Roland, and seconded by Commissioner Boteler that all just and due bills against Johnson County be allowed and ordered paid as submitted, examined in open court and properly endorsed.

All voted aye.

A motion was made by Commissioner Bryant, and seconded by Commissioner Boteler that the following applications for road maintenance on private property be accepted.

I, the undersigned, do hereby request the Commissioners Court of Johnson County to authorize the Commissioner of Precinct Number 3 to direct the use of County employees and equipment to construct and maintain, to-wit: Build terraces on farm off road #207, the following described private road, to-wit: \_\_\_\_\_

A motion was made by Commissioner Roland, and seconded by Commissioner Coward that the Financial report of the Johnson County Memorial Hospital for July 1966 be approved as submitted.

The County Judge read the mileage that had been prepared by the Texas Highway Department and corrected by each commissioner for his individual Precinct. County Judge inquired of each commissioner individually whether they needed additional time to determine the correctness of the mileage in their individual Precincts, and each Commissioner individually announced that they did not need additional time to determine the mileage in their own precincts. Commissioner Coward announced he would like to have additional time to check the mileage in the other Precincts. A discussion was held as to realignment of the Precinct lines and a tentative line was discussed between Precinct 3 and Precinct 4 and each of the commissioners from Precinct 3 and 4 stated that this line was acceptable to each of them. A tentative line was discussed between Precinct 1 and 2 and Commissioner Coward stated that this line was not acceptable to him. Further discussion was held on the subject of

realignment between Precinct 1 and 12, but no decision reached. The item of realignment will be again discussed at the next Commissioners' meeting giving Commissioner Coward time to make any check of any of the Precinct mileage he desires.

THERE BEING NO FURTHER BUSINESS COURT IS HEREBY ADJOURNED.
