RESOLUTION

WHEREAS, on May 10, 1966, at the Twelfth Annual Conference of the Tax Assessor-Collector Association of Texas held in San Antonio, Texas, the following Resolution was passed:

"WHEREAS, the problem and cost of registering motor vehicles has become more acute in the last ten years; and WHEREAS, no increase in fees for handling such motor vehicle registration has been allowed for many years; and,

WHEREAS, the cost of employing help in the registration department has increased to such an extent that the present maximum fee of 30 cents per registration is inadequate to pay the actual cost of such administrative expenses;

THEREFORE, be it resolved that the County Tax Assessor-Collector Association of Texas go on record supporting an increase, such increase to be 60 cents on all registration.

FURTHER, the Jurisprudence Committee be instructed to seek the passage of the necessary legislation to bring about this increase".

WHEREAS, the Commissioners' Court of Johnson County, Texas, believes that the best interests of the citizens of Johnson County, Texas, will be served by the adoption of such legislation;

NOW, THEREFORE, BE IT RESOLVED by the Commissioners' Court of Johnson County, Texas, that the above Resolution passed by the Tax Assessor-Collector Association of Texas by and is hereby adopted and approved, and a copy of this Resolution be forwarded to all the State Senators and Representatives of Johnson County, Texas, recommending to them the passage of the necessary legislation to bring about the increase for the Counties.

A BILL

TO BE ENTITLED

AN ACT to amend Section 11, Chapter 88, Acts of the Forty-first Legislature, Second Called Session, 1929, as amended by Chapter 161, Acts of the Fifty-second Legislature, Regular Session, 1951, providing for fees of Tax Assessors-Collectors for issuing license receipts and license plates; providing that the Tax Assessor-Collector shall pay the entire expense of issuance of such license receipts and license plates and the cost of postage used in mailing same to applicants; providing a saving clause; repealing all laws in conflict herewith; and declaring an emergency.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

Section 1. That Section 11, Chapter 88, Acts of the Forty-first Legislature, Second Called Session, 1929, as amended by Chapter 161, Acts of the Fifty-second Legislature, Regular Session, 1951, be amended to hereafter read as follows:

"Section 11. As compensation for his services under the provisions for this and other laws relating to the registration of vehicles, each County Tax Assessor-Collector shall receive a uniform fee of Sixty Cents (.60) for each receipt issued by him each year pursuant to said laws. Said compensation shall be deducted weekly by each County Tax Assessor-Collector from the gross collection made pursuant to this Act and other laws relating to the registration of Vehicles. Out of the compensation so allowed the County Tax Assessor-Collectors, it is hereby expressly provided and required that they shall pay the entire expense of issuing all license receipts and license plates issued pursuant hereto, including the cost of labor performed in issuing said receipts, license plates and the cost of postage used in mailing same to applicants."

Sec. 2 If any section, subsection, sentence, clause, or phrase of this Act is for any reason held unconstitutional, the unconstitutionality thereof shall not affect the validity of the remaining portion of this Act. The Legislature hereby declares that it would have passed the Act and each section, subsection, sentence, clause, and phrase thereof irrespective of the fact that one or more of the sections, subsections, sentences, clauses or phrases be declared unconstitutional.

Sec. 3 All laws or parts of laws in conflict herewith are hereby repealed to the extend of such conflict.

Sec. 4 The fact that the number of motor vehicle registrations made by County Tax Assessor-Collectors has steadily increased, and the fact that labor and material costs and other administrative expenses which are necessary in the issuance of such registrations have materially increased, and the fact that there has been no increase in the fees allowed Tax Assessor-Collectors for performing this service, creates an emergency and an imperative public necessity that the Constitutional Rule requiring that bills be read on three days in each House be and the same is hereby suspended, and this Act shall take effect and be in force at the beginning of the 196_ registration year and it is so enacted.
