WHEREAS, the United States of America has abolished the documentary stamp law whereby Federal Revenue stamp was required to be placed on a conveyance of real estate.

BE IT RESOLVED by the Commissioners Court of Johnson County, sitting in Cleburne, Texas, that they request the Governor of the State of Texas to include in his call for the special session of the legislature for the year 1968 a provision whereby the legislature might consider the enactment of a state law for documentary stamps.

The Commissioners Court, at its meeting on February 1, 1968, adopted the following policy for their county employees and requests the cooperation of each officeholder in instituting this policy throughout the County.

An employee is entitled to one week's paid vacation for each six months worked in one calendar year. An employee is entitled to accumulate and take a maximum of two weeks' paid vacation in any one calendar year. If an employee resigns his postion, having accumulated one week's vacation, he could be paid for this time, provided the officeholder had money in the budget under extra help to pay for his time, or provided the officeholder did not replace the employee until after the employee's vacation time had expired. To better clarify this policy, the following are some examples:

- (1) An employee commences work on January 1, 1968, After July 1, 1968, he would be eligible for one week's paid vacation. He did not take the week's paid vacation; after January 1, 1969, he would be entitled to two weeks' paid vacation.
- (2) If an employee commences work on January 1, 1968, and if the employee quits on October 1 and has not taken his vaction, he could be paid for one week's vacation, provided the officeholder had money in his budget under Mextra help" to pay for this time, or provided the officeholder did not

replace the employee until after the employee's vacation time had expired. The employee would not receive any vacation pay for the time of July 1 through September 30.

- (1) All pipes will be at least 30" below the surface of the ground, including the road bed, shoulder, bottom of the bar ditch.
 - (2) Persons desiring the permit shall give at least 24 hours' notice before work is begun.
- (3) The dirt will be replaced and tamped every 6". If the road is a gravel road, the surface will be covered with 6" of gravel. If the road is not a gravel road, then tamping is all that will be required.

RETURN OF DEPOSIT:

Upon completion of the work and inspection of the work by the Commissioner of the Prcinct, the above fees will be refunded to the person depositing the same 60 days after the inspection. This would allow time to receive a slow rain, to see that the work is accomplished in accordance with the foregoing standards. If it is necessary for the Commissioner to repair the road or fill the

hole, then customary charges will be levied and this amount retained from the deposit. The balance of the deposit if any will be refunded to the applicant.

WHEREAS, this Commissioners' Court, after due investigation and consideration, has ascertained and determined that it is necessary and advisable to construct certain hospital inprovements in accordance with plans and specifications on file in the office of the County Clerk, and

WHEREAS, the plans, specifications, form of contract documents and minimum wage rates have been reviewed and found to be satisfactory with this governing body, and

WHEREAS, the statutes of the State of Texas, including Article 2368a, Revisēd Civil
Statutes of Texas, 1925, as amended, provide that no county shall make or enter into any contract calling for or requiring the expenditure or payment of \$2,000. or more creating or imposing an obligation or liability of any nature or character upon the county, without first submifting such proposed contract to competitive bidding and advertisement as therein provided, and said statute further provides that when it shall be the county's intention to issue time warrants for payment of all or any portion of a proposed contract, the notice to bidders shall recite that fact, setting forth the maximum amount of the proposed time warrant indebt edness, the maximum rate of interest of such time warrants, and the maximum maturity date thereof; and

WHEREAS, it is the purpose and intent of this Commissioners' Court to receive construction bids, and in the event contract or contracts be executed for such improvements, to issue and deliver to the proper contractor or contractors in payment of all or a portion of the contract price the time warrants of the County, bearing interest at a rate not to exceed 6% per annum, payable annually or semi-annually, and not exceeding the principal sum of \$500,000, the principal of such warrants to be payable serially, with the maximum maturity date to be not later than December 31, 2008; therefore,

BE IT ORDERED BY THE COMMISSIONERS' COURT OF JOHNSON COUNTY, TEXAS;

SECTION 1: That all findings and declarations contained in the preamble hereof are made a part of the judgment of this Commissioners' Court. The plans, specifications, form of contract

documents and minimum wage rates mentioned in the preamble are hereby officially approved and ordered filed with the County Clerk.

SECTION 2: That the County Judge be and he is hereby authorized and directed to do all things necessary to cause to be issued a notice in substantially the following form:

NOTICE TO BIDDERS OF COUNTY'S INTENTION TO LET CONTRACT OR CONTRACTS FOR THE CONSTRUCTION OF HOSPITAL IMPROVEMENTS AND OF THE INTENTION TO ISSUE TIME WARRANTS IN PAYMENT OF ALL OR A PORTION OF THE COST THEREOF

SEALED PROPOSALS addressed to the Honorable Herschel Winn, County Judge, Johnson County, Texas, will be received until 20'clock P. M., on the 29th day of October, 1968 at the County Courthouse, Cleburne, Texas, for furnishing all labor and materials and performing all work in connection with the construction of hospital improvements, to-wit: on additions to Memorial Hospital of Johnson County, Texas and the renovation of the existing structure in connection therewith, in accordance with plans and specifications on file in the Office of the County Clerk, Courthouse, Cleburne, Texas, where they may be examined without charge.

Such proposals will at said time be publicly opened and read aloud and all proposals will be referred to the Architect for tabulation and checking, with the final award of contract proposed to be made on November 12, 1968, at which time the hereinafter mentioned warrants will be authorized in payment of all or a part of the contract price.

DETAILED PLANS, SPECIFICATIONS, AND CONTRACT DOCUMENTS may be examined at the office of the Architect, M. M. Moseley, 215 West Main, Fredericksburg, Texas, 78624, or a copy of same may be obtained from said Architect upon a deposit of \$50.00. The deposit will be returned to each actual bidder who returns the plans and specifications within three (3) days of the bid opening.

A CERTIFIED OR CASHIER'S CHECK issued by a bank satisfactory to the Commissioners' Court, payable to the order of the County Judge, Johnson County, Texas, or an acceptable bid bond given by a reliable surety company authorized to do business in the State of Texas, shall be submitted by each bidder, in an amount not less than two per cent (2%) of the total bid as a guarantee that the bidder will promptly enter into contract with the County, and bids without the required check or bid bond will not be considered.

THE SUCCESSFUL BIDDER will be required to furnish a performance bond and a payment bond, each in the amount of the contract, written by a responsible surety company authorized to do business in the State of Texas, and satisfactory to the Commissioners' Court, as required by Article 5160, V.A.T.C.S.

Attention is directed to Article 5159a, V.A.T.C.S., which requires that not less than the general prevailing rates of per diem wages for work of a similar character in the locality where the work is performed shall be paid all laborers, workmen and mechanics employed in the construction of public works.

Bidders should carefully examine the plans, specifications and other documents, visit the site of the work, and fully inform themselves as to all conditions and matters which can in any way affect the work or the costs thereof. Should a bidder find discrepancies in, or omissions from, the Plans, Specifications or other documents, or should he be in doubt as to their meaning, he should at once notify the Architect and obtain clarification prior to submitting any bid.

Notice is hereby further given that it is the intention of the Commissioners' Court of Johnson County, to pay all or a portion of the contract price by the issuance and delivery to the contractor of the interest bearing time warrants of said County, the principal and interest of which are to be payable from ad valorem taxes to be levied under Article VIII, Section 9 of the Constitution of Texas, such warrants to bear interest at a rate not to exceed 6% per annum, payable annually or semi-annually, and to be issued in the principal sum of not to exceed \$500,000, payable serially, the maximum maturity date to be not later than December 31, 2008; and the successful contractor or contractors shall receive such warrants in installments based upon periodic estimates approved by the Commissioners' Court. Any

portion of the contract price not paid through the issuance of such warrants will be paid in cash out of funds legally available for that purpose.

The County has made arrangements for the cpntrdetor to dispose of the warrants herein mentioned at their face value if he elects to do so, in the proposal submitted, or the contractor may retain the warrants for his own account. Unless the proposal clearly shows the election is made to retain the warrants, the contractor must agree to deliver the warrants at face value to the party with whom the County has made such arrangements, as more fully explained in the "Special Conditions Relating to Payment", included in the contract documents.

NO BID may be withdrawn after the scheduled closing time for receipt of bids for at least 45 calendar days.

The County reserves the right to reject any and all bids and to award the contract to the bidder or bidders who, in the opinion of the Commissioners' Court, offer the proposal or proposals to the best interest of the County, and to waive formalities.
