COUNTY OF JOHNSON

BE IT REMEMBERED AT A SPECIAL MEETING of the Commissioners Court in and for Johnson County, Texas, on the above mentioned date at the Courthouse in Cleburne, Texas, with the following members present: Thomas E. Ball, County Judge, C. W. Atwood, Commissioner of Precinct No. 1, W. R. Bryant, Commissioner of Precinct No. 2, W. I. Boteler, Commissioner of Precinct No. 3, M. W. Roland, Commissioner of Precinct No. 4, Louis B. Lee, County Clerk, Lorene Moreland, County Auditor, J. C. Bennett, Assistant County Auditor.

A motion was made by Commissioner Roland and seconded by Commissioner Boteler that all County employees be granted at 5% increase as follows:

That we grant a 5% "cost of living" increase to all County employees, elected or appointed, except the following named positions where adjustment have already been made: Assistant Auditor, Chief Deputy in County Clerk's office, Chief Deputy Tax Assessor-Collector, Secretary to Probation Officer, Secretary in County Agents' office, Sheriff's Office Deputy (Mrs. Woodrow's position) and Deputy District Clerk. The above to be effective January 1, 1970.

Also the following motion was made by Commissioner Roland, seconded by Commissioner Bryant, and carried by unanimous vote:

That we set up the position of Chief Deputy in the County Clerk's Office at a salary of \$400.00 per month, to be effective February 1, 1970.

All voted aye

A motion was made by Commissioner Roland and seconded by Commissioner Boteler that Johnson County purchase 4 County maps at \$25.00 each from the Directory Service Company of Algon, Iowa to be delivered in March or April 1970.

All voted aye

Upon a motion made by Commissioner Bryant and seconded by Commissioner Atwood with motion passed unanimously the Commissioners Court of Johnson County hereby authorizes the Commissioner shown below to use County employees and equipment to construct and/or maintain a private road within his precinct as shown below, as authorized by Article 6812b, Texas Civil Statutes, to-wit:

A motion was made by Commissioner Boteler and seconded by Commissioner Roland that the Budget for 1970 be amended in the amount necessary due to the 5% increase in cost of living pay rolls and added new position set up by the court.

All voted aye

A motion was made by Commissioner Atwood, seconded by Commissioner Roland, that Mozelle F. Browning's salary be adjusted to \$400.00 a month, the difference in what she now draws and the \$400.00 will be additional compensation for her work with the Child Welfare Board and the Juvenile Court, and this is a salary readjustment and she will not participate in the 5% cost of living increase given employees in an earlier action this morning.

All voted aye

A motion was made by Commissioner Atwood, seconded by Commissioner Boteler, that the clerical employees in the Tax Assessor-Collector's office be raised from the present \$338.00 per month to \$345.00 per month and that they will receive the 5% cost of living increase also.

All voted aye
