BE IT REMEMBERED AT A REGULAR MEETIING of the Commissioners' Court in and for Johnson County, Texas, on the above mentioned date at the Courthouse at Cleburne, Texas, with the following members present: Thomas E. Ball, County Judge, C. W. Atwood, Commissioner of Precinct No. 1, W. R. Bryant, Commissioner of Precinct No. 2, W. I. Boteler, Commissioner of Precinct No. 3, M. W. Roland, Commissioner of Precinct No. 4, Louis B. Lee, County Clerk, Lorene Moreland, County Auditor, Rev. Dave Evans, Jess Everett, Marshall Young, Burleson City Manager, Ruth Morris, Brooks Smith, Ralph Garrett, Kirby Ables and John Butner.

A motion was made by Commissioner Atwood and seconded by Commissioner Boteler that all bills against Johnson County be allowed and ordered paid as submitted, examined in open court and properly endorsed.

All voted aye.

A motion was made by Commissioner Boteler and seconded by Commissioner Roland with motion passing unanimously the Commissioners' Court of Johnson County hereby authorizes the Commissioner shown below to use County employees and equipment to construct and/or maintain a private road within his precinct as shown below, as authorized by Article 6821b, Texas Statutes, to-wit:

A motion was made by Commissioner Atwood and seconded by Commissioner Bryant that the Court approve the extension of Ridgeway Drive from U. S. Highway 67 to County Road 900 as a Farm to Market Road, this to include County Road 1125.

All voted aye.

A motion was made by Commissioner Atwood and seconded by Commissioner Roland that as an alternative (should the route not meet with the approval of the Texas Highway Dept.), that the second road to be designated as a Farm to Market Road be the Nolan River Road from U. S. Highway 67 to the Lake Pat Cleburne dam site.

All voted aye.

A motion was made by Commissioner Atwood and seconded by Commissioner Bryant that the following policy be established relative to the Community Room:

(1) That a minimum fee of \$7.50 be charged for the services of the custodian for opening and closing the courthouse up to 10:00 P.M.

(2) That if two or more meetings are held at the same time and date a minimum fee of \$5.00 will be charged each organization.

(3) That the Community Room shall be made available only to public organizations and not to private parties.

(4) That in the event meetings last longer than 10:00 o'clock P.M. the custodian shall be paid \$2.50 per hour in addition for each hour after 10:00 P.M.

A motion was made by Commissioner Roland, seconded by Commissioner Atwood, that we employ C. E. Hendricks as building custodian at \$300.00 per month, effective September 1, 1970.

All voted aye.

A motion was made by Commissioner Atwood and seconded by Commissioner Roland, that the public hearing on our 1971 hearing budget be set for September 30, 1970 at 9:00 A. M., to be held in the County Courtroom.

All voted aye.

A motion was made by Commissioner Boteler and seconded by Commissioner Roland to set up \$3,000.00 in the 1971 budget to cover maintenance on the soil conservation retention dams in Johnson County, as needed, payments to be paid out of the Right of Way Fund.

All voted aye.

A motion was made by Commissioner Boteler and seconded by Commissioner Bryant that the Rolling Acres Plat be approved.

All voted aye.

There being no further business Court is hereby adjourned.
