AT A SPECIAL MEETING OF THE COMMISSIONERS' COURT in and for Johnson County, Texas, on the above mentioned date at the Courthouse at Cleburne, Texas, with the following members present: Thomas E. Ball, County Judge, C. W. Atwood, Commissioner of Precinct No. 1, O. B. Hadley, Commissioner of Precinct No. 2, W. I. Boteler, Commissioner of Precinct No. 3, B. B. Aldridge, Commissioner of Precinct No. 4, and Joe L. Townes, County Clerk.

A motion was made by Commissioner Atwood and seconded by Commissioner Aldridge to adopt the following resolution:

STATE OF TEXAS

KNOW ALL MEN BY THESE PRESENTS:

COUNTY OF JOHNSON

WHEREAS, the Board of Regents of the Hill County Junior college has offered to establish a branch of such college at Cleburne, to be known as "Johnson County College, Cleburne, Texas, a branch of the Hill County Junior College, Hillsboro, Texas"; and

WHEREAS, the Board of Regents will establish such college at Cleburne at the expense of the Hill County Junior College and without any expense to the tax payers of Johnson County, Texas: and

WHEREAS, the Chamber of Commerce will make available to the Hill County Junior College the Civic Center Building of the Chamber of Commerce, formerly known as the "National Guard Armory Building:", which the Chamber of Commerce will negotiate as to the rent, utilities, etc.; and

WHEREAS, the Commissioners' Court has for many years recognized the need for an institution of higher learning in this County because of the many advantages this would offer the youth of Johnson County, who would be relieved of the time and expense involved in going outside of the County to pursue their education, and which would permit many of them to attend college who otherwise would not be able to do so:

THEREFORE, BE IT RESOLVED that the Commissioners' Court, in a special called meeting, heartily endorses the establishment of a branch of the Hill County Junior College in Johnson County, and we do pledge our wholehearted support and urge other organizations and associations to adopt similar resolutions of cooperation.
