COUNTY OF JOHNSON March 10, 1975

BE IT REMEMBERED AT A REGULAR MEETING OF THE COMMISSIONERS' COURT IN AND FOR JOHNSON COUNTY, TEXAS, on the above-mentioned date at the courthouse in Cleburne, Texas, with the following members present: C.C. "Kit" Cooke County Judge; Commissioner Precinct No.1 C.W. Atwood ; Commissioner Precinct No.2 O.B. Hadley ; Commissioner Precinct No.3 W.I. Boteler ; Commissioner Precinct No.4 B.B. Aldridge and Joe L. Townes County Clerk.

Invocation was given by Commissioner B.B. Aldridge.

Tommy Tatum, County Extension Agent, presented the annual report of the Texas Agent's Extension Services and the results of Johnson County Agriculture Demonstrations for 1974.

The Election Judges of Box 10 and 11 Burleson, the County Clerk and the Tax Assessor and Collector shall make new precinct boundaries for box 10 Burleson and for box 26 Burleson. Box 10 Burleson will be divided, which shall create box 26. official action will be taken June 1, 1975. Box 6 now has 110 registered voters and will not be discontinued.

A motion was made by Commissioner Boteler and seconded by Comm. Hadley to defer the recommendation of the Johnson County Bar Association in reference to a resolution supporting the creation of a new District Court concurrent with the present District Court lines.

All voted aye.

Mr. L.G. Crawford, representative of the Lone Star Gas Co. appeared before the court re-affirming that the Lone Star Gas Company will help financially to repair County Roads damaged by their company in laying gas lines in Johnson County.

A motion was made by Commissioner Aldridge and seconded by Commissioner Boteler to grant Sheriff Stuart Huffman the authority to establish a Reserve Sheriff's Unit for Johnson County composed of members who have law enforcement certification.

All voted aye.

A motion was made by Commissioner Atwood and seconded by Commissioner Aldridge to authorize the Garden Culture Club to landscape the flower Gardens around the Courthouse. The Garden Club will furnish the plants and the County will furnish one man from Commissioners Prec #2 for labor for three or four days.

All voted aye.

Trittes Birdwell, County Juvenile Officer, stated to the Court that he needed office space now occupied by the American Red Cross for his secretarial needs. The Court will make a visual inspection of the area and make a decision on this matter.

A motion was made by Commissioner Atwood and seconded by Commissioner Boteler to appoint Lowell Smith Jr. to fill the unexpired term of Lowell Smith Sr. to the Johnson County Hospital Board. The term will expire April 2, 1976.

All voted aye.

A motion was made by Commissioner Atwood and seconded by Commissioner Hadley to approve Depository Pledge Contract of the First National Bank of Cleburne, Texas and ordered same filed in the Commissioners Court Minutes and Bond records of the County Clerk's Office.

County Road 206 A is in Precinct 3 - decision of County Attorney John Mac Lean.

A motion was made by Commissioner Aldridge and seconded by Commissioner Atwood to approve interium urban map of Cleburne and to authorize County Judge C.C. Cooke to sign same for the Commissioners Court.

All voted aye.

2. C.R. 206 from F.M. 1807 to F.M. 2258

3. C.R. 305 from Highway 171 to F.M. 110
