Invocation was given by Judge Cooke.

The Court took no official action on the discussion of the Septic Tank Ordinance for Johnson County after hearing a report on the subject from Mr. Charlie Morgan, County Engineer, in regard to fees and procedures used in other counties. The court decided further study was needed before reaching a decision.

A motion was made by Commissioner Atwood and seconded by Commissioner Aldridge to comply with the 1965 voting rights acts of 1965 to print 5% of the ballots for the Nov.4, 1975 Constitutional Amendment Election in Spanish, have instructions to voters printed in Spanish and have one interpreter stationed at the County wide upon call of any election judge.

All voted aye.

The Court received a report from the County Extension Agent for July and August 1975.

After hearing a complaint against the developers of Oakview Farms Estates from citizens on County Road 602-D, the Court advised the land owners to bring the roads up to specifications required by subdivision rules and regulations in 1968. After two years the county will accept the road for maintenance.

A motion was made by Commissioner Hadley and seconded by Commissioner Atwood to amend the Sheriff's budget to cover the bid of Pernell Motor Co. in the amount of \$5,080.00. The Sheriff's budget allowed only \$5,000.00 for the purchase of an automobile for 1975.

All voted aye.

A motion was made by Commissioner Aldridge and seconded by Commissioner Hadley that specifications on any and all bids in the future must be approved by the court before the County Auditor advertises for said bids. The bid shall include the "right to accept or reject" any or all bids.

All voted aye.

A motion was made by Commissioner Aldridge and seconded by Commissioner Boteler to approve minutes as read.

All voted aye.

A motion was made by Commissioner Atwood and seconded by Commissioner Boteler to approve payment of monthly bills as read by the County Auditor.

All voted aye.

A motion was made by Commissioner Boteler and seconded by Commissioner Hadley to rescind the bid of Bon Cosby Chevrolet in the amount of \$4,850.00 accepted by the court on Sept.2, 1975, as the bid did not meet the specifications and to accept the bid of Pernell Motor Co. as follows:

All voted aye.

The list of delinquent and insolvent tax payers for the year 1974, as presented by the Tax Assessor Collector, was approved and signed in open court. The amounts:
