Invocation was given by W.I. Boteler, Commissioner of Precinct No.3.

A motion was made by Commissioner C.W. Atwood and seconded by Commissioner W.I. Boteler to adopt Tax Rate for 1976, as follows:

Hadley and seconded by Commissioner Aldridge to have the County Surveyor survey County Road #803 at its entrance into Oak Parks Estates, subdivision developed by E.L. Trimble, which is only 22.6' wide at this point. After the survey the court will determine what legal action is necessary, if any, upon recommendations of the County Attorney.
