A motion was made by Commissioner Boteler and seconded by Commissioner Aldridge to accept Lateral Road Refund from State of Texas in the amount of \$51,668.90 to be used for the construction of county roads.

A motion was made by Commissioner Boteler and seconded by Commissioner Atwood not to accept the Texas County & District Retirement System for former employee's to restore their previous service as outlined in the following letter:

A motion was made by Commissioner Boteler and seconded by Commissioner Hadley to participate in military assistance to Safety and Traffic program of \$200.00 for radio communication equipment for M.A.S.T. operational rescue units.

Thank You! Commissioner C.W. Atwood Voted "No".

O.B. Hadley, W.I. Boteler and B.B. Aldridge voted "Yes".

A motion was made by Commissioner Atwood and seconded by Commissioner Hadley to authorize the County Auditor to advertise for bids on the purchase of 10,000 county road maps. The bid must be in by the 1st of September. County will charge 35¢ per map.

All voted aye.

A motion was made by Commissioner Atwood and seconded by Commissioner Aldridge to hold a budget workshop hearing for the 1976 Johnson County budget in the office of County Judge Cooke. The meeting will start at 10:00 A.M. Tuesday Sept 7, 8, 9 and 10 or until the hearing is completed and to hold a public hearing on same on Monday Oct.11, 1976 at 10:00 A.M.
