Townes, County Clerk.

Invocation was given by Joe L. Townes, County Clerk.

A motion was made by Commissioner Atwood and seconded by Commissioner Boteler to appoint Sammy Glenn, Constable Precinct No.1, to fill the unexpired term of C.R. Covington, deceased, until December 31, 1976.
