BE IT REMEMBERED AT A REGULAR MEETING OF THE COMMISSIONER'S COURT IN AND FOR JOHNSON COUNTY, TEXAS, on the above-mentioned date at the Courthouse in Cleburne, Texas, with the following members present <u>C.C. Cooke</u> County Judge; Commissioner Precinct No.1 <u>C.W. Atwood</u>; Commissioner Precinct No.2 <u>O.B. Hadley</u>; Commissioner Precinct No.3 <u>W.I. Boteler</u>; Commissioner Precinct No.4 B.B Aldridge and Joe L. Townes, County Clerk.

Invocation was made by Commissioner Atwood and seconded by Comm. Hadley to approve payment of annual membership dues for N.C.T.C.O.G. from 10-1-76 to 9-30-77 @ \$275.00 per year.

All voted aye.

After canvass of the results for the General Election held Nov. 2, 1976, a motion was made by Commissioner Atwood and seconded by Comm. Aldridge to approve the results and certify to the Secretary of State. All voted aye.

A motion was made by Commissioner Aldridge and seconded by Comm. Boteler to mail each prec. Election Judge in Johnson County a certificate of appreciation for their work in the Nov. 2, 1976 General Election.

All voted aye.

The County Judge informed the Court that a formal opening and dedication of the Texas State Employment Office housed in the Southeast corner of the Courthouse is to be held at 10:00 A.M. Wednesday Nov. 13, 1976 and that the office will be open daily Tuesday through Friday of each week.

A motion was made by Judge Cooke and seconded by Commissioner Atwood to increase the monthly salary of Sheriff Deputies Jimmy Scarber and Jimmy Watkins by 12% per month effective Oct. 1, 1976.

All voted aye.

Commissioner Atwood, Prec #1, advised the County Judge that it was alright for the West Texas Gulf Pipe Line Co. to proceed with their work on F.M. 200.

A motion was made by Commissioner Hadley and seconded by Comm. Boteler to give tentative approval for the County Auditor to sign necessary forms to obtain any anti-recession grant money available to the County if there is no conflict with the Davis Bacon Act.

All voted aye.

Sheriff Huffman appeared before the Court stating that he will not approve a 5% cost of living increase for deputies Jimmy Scarber or Jimmy Watkins for 1977.

The Court did not approve the request of Sheriff Huffman to replace a Deputy Sheriff's uniform which he stated was ruined in line of duty during rescue operations at Hamms Creek.

The County Judge notified the court that the American Legion C.W. DeLario Post #50 had donated an American flag to the County and were going to donate a Texas flag to be flown in place of the bi-centennial flag.

A motion was made by Commissioner Atwood and seconded by Comm. Boteler to approve the minutes of the previous meeting as read by the County Clerk.

All voted aye.

A motion was made by Commissioner Hadley and seconded by Comm. Boteler to approve monthly bills as read by the County Auditor. All voted aye.

A motion was made by Commissioner Aldridge and seconded by Commissioner Atwood to adjourn.

All voted aye.
