#### Dear Sirs:

Governor Dolph Briscoe appointed me to the newly created 249th District Court for Johnson and Somervell Counties on August 16, 1977. The effective date of the Court is September 1, 1977. I have accepted the appointment.

I hereby tender my resignation as County Judge of Johnson County to be effective immediately upon receipt and by approval of this Court.

I have enjoyed my service as County Judge of this fine County and I feel that we have made great strides in the development of this County into a metropolitan area. There are several unfinished pieces of business that I direct your attention to:

- 1. Right of way must be purchased for Highways 287 and 377.
  - 2. The Commissioner's Court must consider whether to adopt the Flood Insurance Program for the citizens of Johnson County.
  - 3. The Commissioner's Court must finalize plans for the Justice Department under the Voting Rights Act of 1965 for the creation of the two(2) new voting boxes in Johnson County.
  - 4. The Commissioner's Court must prepare itself for a Constitutional Election to be held in November.
  - The Commissioner's Court must wrap up final stages of the Johnson County jail renovation.
  - 6. And finally the Commissioner's Court must adopt a Budget for 1978 for Johnson County which also includes the Revenue Sharing Expenditures.

I am hereby transmitting to the Johnson County Commissioner's Court through Bob Wylie, Johnson County Auditor, a proposed balanced budget for 1978. This budget gives an across-the-board pay increase of five percent(5%) to all County employees. This proposal is strictly for your advisement and is not binding. However, it does meet the requirements of the Courty Judge who is

the Chief Budget Officer of the County. This budget also leaves the County with a seventy-thousand dollar(\$70,000.00) surplus.

This letter is directed to you as notification that I am terminating from the position of Juvenile Officer, effective October 1, 1977.

I leave confident in the knowledge that you are receiving a department that is superior to the one that I found when I came. As you know, we have initiated a policy manual, social history reports and updated all files and records. This department has also applied for, received and administrated grant funds from the Texas Youth Council. With these funds, the Juvenile Department has been able to establish foster homes and other placements as alternatives to commitment to the Texas Youth Council. We have also initiated family counseling and individual counseling for youth in trouble.

It is due to the indifference and the inability to take positive action by the Commissioners Court that I feel that I must leave this position. Until the Commissioners Court of Johnson County feels that it is necessary to take action on the juvenile problem we are facing in our county, my successor will be faced with an insurmountable problem.

I would like to express my appreciation to both of you for the help and assistance that you have given me in the past. In working with you, I have learned a great deal and hold you both in high regard.

## REGULATIONS PERTAINING TO INDIVIDUALS WHO ADMINISTER MASSAGES AND ESTABLISH-MENTS WHERE MASSAGES ARE ADMINISTERED

Section 1. DEFINITIONS.

In these Regulations:

- (1) "Massage" means the rubbing, kneading, tapping compression, vibration, application of friction, or percussion of the human body or parts of it by hand or with an instrument or apparatus.
  - (2) "Massager" means an individual who administers massages for compensation.
- (3) "Massage Establishment" means a business establishment where massagers practice massage.
  - (4) "Sheriff" means the Sheriff of Johnson County, Texas.
- (5) "Health Officer" means the Health Officer of Johnson County, Texas, or his designee.

Section 2. LICENSE.

It shall be unlawful for any individual, association, or corporation to operate a massage establishment without first having obtained a license therefor from the Sheriff in accordance with the provisions of these Regulations, or to operate a massage establishment after such license has been revoked, or during a period for which such license has been suspended. Such license shall be issued only upon the payment of the fee specified in these Regulations and upon the approval in writing of the Health Officer. Such license shall expire on the 31st day of December of each year.

Section 3. DISPLAY OF LICENSE.

The license required by these Regulations shall be posted and kept in some conspicuous place in the massage establishment.

Section 4. INVESTIGATION OF APPLICANT.

After an application has been made for issuance of an original license or a renewal of an existing license to operate a massage establishment as defined herein, the Sheriff, as the Inspecting and Licensing Officer under these Regulations, shall determine whether the applicant has been finally convicted in any court of theft, fornication, sodomy, procuring, pandering, keeping a bawdy house, keeping an assignation house, engaging in prostitution or engaging in assignation,

or any offense denounced by Chapter 43 of the Penal Code, or whether such establishment employs any person who has been finally convicted in any court of any such offense.

Section 5. NAMES AND MEDICAL CERTIFICATES OF EMPLOYEES.

At the time of making application for the license required by these Regulations the applicant shall furnish to the Sheriff and the Health Officer the names and addresses of all employees of the massage establishment and all such employees shall be required to secure from the Health Officer a medical certificate certifying that such employee has been examined and that such examination discloses the fact that such person employed, or to be employed by such establishment, is free from any infectuous or communicable disease. Such medical certificate shall be renewed annually by the Health Officer.

Section 6. LICENSE FEE.

The annual license fee shall be Fifty Dollars (\$50.00) for each such establishment. If the license is obtained between January 1st and June 30th of any year, the full amount of such fee shall be paid. If such license is obtained between July 1st and December 31st of any year, the fee shall be one-half of such amount. No refund of license fees shall be made. The Sheriff shall pay over to the County Treasurer all license fees collected.

Section 7. REFUSAL TO ISSUE OR RENEW.

The Sheriff shall refuse to issue or renew any license required by these Regulations in the case of any applicant who has been finally convicted of any of the offenses set out in Section 4 of these Regulations; or in the case of any applicant who employs in such establishment any person who has been finally convicted of any such offense.

Section 8. REVOCATION AND SUSPENSION.

- (a) The license issued pursuant to these Regulations shall be revoked upon funal conviction of the holder of such license for any of the offenses set out in Section 4. of these Regulations.
- (b). The license issued pursuant to this Chapter shall be suspended for a period of not less than 30 days nor more than 90 days upon final conviction in any court of the holder of such license for a violation of any statute of this State.

- (c) Any license issued pursuant to these Regulations shall be suspended for a period of 90 days upon the final conviction in any court of any employee of such massage establishment for any offense set out in Section 4 of these Regulations, or a violation of any provision of these Regulations.
- (d) Written notice of such revocation or suspension shall be given by the Sheriff to the holder of such license at the holder's last known business address.

No massage establishment shall be kept open for any purpose between the hours of 10:00 P.M. and 8:00 A.M.

Section 10. LIVING QUARTERS PROHIBITED.

HOURS OF OPERATION.

Section 9.

No massage establishment shall be operated or conducted in connection either directly or indirectly with any place used for living or sleeping quarters.

Section 11. INSPECTION OF LICENSED PREMISES.

- (a) Acceptance of a license issued under these Regulations shall constitute an express agreement and consent on the part of the licensee that the Sheriff, any of his authorized representatives, or the Health Officer shall at all times have the right and privilege of freely entering upon licensed premises for the purpose of ascertaining compliance with these Regulations.
- (b) In addition to the penalty authorized by Section 16 of these Regulations, refusing, preventing, or impeding any such inspection shall be grounds for revocation of license.

Section 12. LIST OF EMPLOYEES.

The manager of person in charge of a massage establishment shall keep a list of the names and addresses of all employees, both on duty and off duty, and such list shall be shown to any peace officer upon request.

Section 13. SANITARY REQUIREMENTS.

(a) It shall be the duty of every person conducting or operating a massage establishment to keep the same at all times in a clean and sanitary condition. All instruments and mechanical, therapeutic, and bathing devices or parts thereof, that come in contact with the human body, shall be sterilized by a modern and approved method of sterilization before initial use, and any such instruments

and devices or parts thereof, after having been used upon one patro, shall be sterilized before being used upon another. All towels and linens furnished for the use of one patron shall not be furnished for the use of another until thoroughly laundered.

- (b) All massagers shall wash their hands thoroughly before administering massage manipulations to each patron accomodated.
- (c) No person suffering from a communicable disease shall work or be employed in a massage establishment.
- (d) No person shall be accommodated as a patron within a massage establishment when to the knowledge of the owner, person in control, or an employee, such person is suffering from a communicable disease.

Section 14. MASSAGE OF OPPOSITE SEX PROHIBITED.

It shall be unlawful for any person to administer a massage to any person of the opposite sex.

Section 15. CLOTHING.

Massagers and other persons employed by or working in massage establishments shall, at all times when in the massage establishment, wear clothing which cannot be seen through and which covers the torso and extends at least to the knee.

Section 16. PENALTY.

A person who violates any provision of this Regulation commits a Class B. 'Misdemeanor.

Section 17. DEFENSES.

- (a) It is a defense to prosecution under these Regulations that the actor was a licensed physical therapist, a licensed athletic trainer, a licensed cosmetologist, or a licensed barber, performing functions authorized under the license held, or that the actor was a licensed physician or chiropractor, or an individual working under the direct supervision of a licensed physician or chiropractor, while engaged in practicing the healing arts.
- (b) It is a defense to prosecution under these Regulations that the administration of massage was for recognized therapeutic purposes in a hospital, nursing home, or a similar health care facility.

#### PURPOSE OF MEETING:

DROUGHT: All present were in agreement that current drought conditions had reached significant proportions warranting requesting the County Judge and Commissioners Court to request the Governor to declare Johnson County a "Disaster Area".

In reviewing rainfall report by Dr. O. T. Smyth, M.D. - Co-operative Weather Observer for Johnson County, it was noted that the county had received only 6 inches of rain from May 1, 1977 to present time and 2.6 of this fell at one time in June, followed by record breaking heat wave of several days in excess of 100 degrees.

Water supply (surface water) is reaching critical stage. Many ponds dry - some that have never previously gone dry, others becoming stagnant mud holes.

Pastures are already gone - have already had several killing frost - no chance for this to improve - all livestock owners have been feeding for several weeks. Many are selling off entire herds, others are culling and going to hang on for a while longer.

Hay situation is critical - group estimates that less than one fourth of a crop was harvested - one fair cutting was all anyone was able to harvest.

Small grains - very little has been seeded. Some planted came up and was destroyed by army worms - if worms didn\*t get it then it died from lack of moisture.

Feed situation - there is no grain in the hands of livestock owners - purchases could be made but producers are not financially able to enter into a total feeding situation. It was the decision of the group that all assistance available through regular USDA programs should be made available to producers as soon as possible.

Each agency head agreed to keep the chairman informed of progress in carrying out the emergency program of their agencies.

RE: Fractional Service Retirement Benefits

Between Systems

Our memorandum of September 12, 1977 regarding amendments to our law, the Texas County and District Retirement System Act, noted that each TCDRS subdivision may elect to participate in a program of fractional service retirement benefits encompassing, in addition to service credit with BOARD OF TRUSTEES TCDRS, credit for service allowed by the Teachers Retirement System of Texas, the Employees Retirement System of Texas, and certain cities in the Texas Municipal Retirement System which elect to participate in the program.

> The program provides that creditable service allowed by any of the four Systems listed above may be combined for the purpose of satisfying the length of service requirement. for service retirement eligibility provided that combination satisfies the service retirement eligibility requirements of each of the Systems where the service credit is to be combined. The combination of creditable service is allowed for members already receiving a retirement benefit from one or more of the Systems as well as for members not yet retired.

Qualification for a retirement benefit as a result of the combination of creditable service allowed by two or more of the statewide public systems will entitle the member to apply for service retirement and, on application, to receive a retirement benefit from each System allowing service credit to the extent of the retirement reserves accumulated with each System.

We would ask, then, that the governing body of each TCDRS subdivision notify our office by January 1, 1978 of its decision as to participation in the fractional service retirement benefits program. A certified copy of an order, resolution, or minutes of the governing body would constitute acceptable notice. As previously noted in our earlier memorandum, a subdivision which has not notified our office of an election not to participate by February 1, 1978 will be construed as having elected to participate in the fractional credits program.

We would be pleased to discuss this program with you further should you have any questions.
