BE IT REMEMBERED AT A REGULAR MEETING OF THE COMMISSIONERS' COURT IN AND FOR JOHNSON COUNTY, TEXAS, on the above-mentioned date at the Courthouse in Cleburne, Johnson County, Texas, with the following members present: C.W. Atwood, Commissioner of Precinct No.1, O.B. Hadley, Commissioner of Precinct No.2, Loyd H. Reese, Commissioner of Precinct No.3, B.B. Aldridge, Commissioner of Precinct No.3, Tommy Altaras, County Judge and Joe L. Townes, County Clerk. Invocation was given by Loyd Reese.

A motion was made by C.W. Atwood and seconded by Commissioner Aldridge to authorize the County School Superintendent to invest \$8,000.00 from the Permanent Savings Fund in a Certificate of Deposit for four (4) years.

All voted aye.

No action was taken by the Court on the Oak Park Estate road entrance.

Mr. Vernon Stokes will be notified when the survey is completed on the property to be acquired.

Jim Walker, Commander, and Lewis Prescher, Bobbie Williams, and Jim Black of C.E. DeLario Post 50, the American Legion, made a formal presentation of the American Flag, Texas Flag and Staffs, to be used in the Johnson County Courtroom.

A motion was made by O.B. Hadley and seconded by Commissioner Aldridge to approve Final Plat of Quail Park Run, Section I.

A motion was made by O.B. Hadley and seconded by Commissioner Reese to approve Final Plat of Rolling Meadows, Section I.

A motion was made by Commissioner Reese and seconded by Commissioner Atwood to approve Preliminary Plat of Trailwood Estates, with the stipulation that buildings cannot be constructed in the flood easement area, as defined on the Plat.

After hearing a report from County Auditor, Robert Wylie, on the Travis County Flood Hazard Plan, a motion was made by Tommy Altaras and seconded by B.B. Aldridge to table the Flood Hazard Insurance Plan for Johnson County for further study.

No action was taken by the court on the report made by County Auditor, Robert Wylie, in regard to a ladies restroom being constructed in the Lawyers Lounge on the second floor. An estimated cost for two stalls and one wash basin will run between \$1,500.00 and \$2,000.00, provided no major damage will be done to the original plumbing in the adjacent men's rest room, which will serve as the main sewer line.

A motion was made by Commissioner Atwood and seconded by Commissioner Hadley to table the proposal made by Nitsche Insurance Agency for Public Officials and Employees Liability until the County Attorney studies the policy and advises the court, proposal as follows:
