Invocation was given by Judge Altaras.

A request for additional funds for the Johnson County Rural Fire

Commission was presented to the Court by Bob Craft, Chairman, and Roy Forsythe,

Treasurer, and also stating that an referendum to increase the tax on property

will be presented to the people for a vote in the early fall.

A motion was made by C.W. Atwood and seconded by O.B. Hadley to increase the amount the County is giving for 1978 to the same amount as was given in 1977, but in no event to exceed \$71,250.00.

All voted aye.

Shirley Calloway an employee in the County Tax Office asked the Court to permit courthouse employees the right to use the old rest room on the first floor of the Courthouse, when not in use by the 249th District Court as a jury room.

The Court stated that they would try to work out an arrangement with District Judge C.C. Cooke that will be suitable to all concerned.

A motion was made by B.B. Aldridge seconded by C.W. Atwood to approve the deputation of Burl Junior Carroll as Deputy Sheriff for Johnson County.

A motion was made by C.W. Atwood and seconded by B.B. Aldridge to authorize payment of monthly bills as read by the County Auditor.
