Bob McJilton, Cleburne, Manager of the Southwestern Bell Telephone Company, appeared before the court to notify them of the pre-hearing conference for a state wide rate change to be held at the Public Utility Commission of Texas at the Commission Offices, Austin, Texas, on July 13, 1979.

Judge Altaras informed the court of a conference to be held in Austin, July 13, 1979, for the purpose of explaining Senate Bill 621, also the possibility of the county hiring the services of a Tax Specialist out of Austin, Jack McCreary, to appear at a meeting of the Commissioners' Court to explain provisions of Senate Bill 621 to the court, or to call a public meting for the same purpose.

A motion was made by Commissioner Atwood and seconded by Commissioner Aldridge to send the following request to Governor Clements to restore Johnson County Lateral Road Funds.

County Judge, Tommy Altaras, informed the court that he has accepted the petition to abolish the Library Chapel Independent School District, and that he has set the date in accordance with the Texas Election Code, as August 11, 1979, to be held at the Library Chapel Schoolhouse from 7:00 A.M. to 7:00 P.M. He will appoint an election official and two (2) election judges.

No action was taken by the court on the request of Commissioner B.B. Aldridge to repair a back-hoe for precinct No.4.

The court postponed for further study proposals for Group Hospitalization for Johnson County Employees.

A motion was made by Commissioner Atwood and seconded by Commissioner Lambert to accept the bid of Billy Mullins for repair of the dome in the courthouse.

A motion was made by Commissioner Atwood and seconded by Commissioner Reese to ratify the Computer Contract with First Municipal Leasing Finance Corporation and amend the technical name to the County Judge, instead of the County Auditor.

All voted aye.

A motion was made by Commissioner Lambert and seconded by Commissioner Reese to approve payment of monthly bills as read by the County Auditor.

Heard a report from the Adult Probation Department, showing a collection of fees and restitution for 1978 in the amount of \$175,000.00.

A motion was made by Commissioner Atwood and seconded by Commissioner Lambert to authorize County Attorney, Dan Boulware, to make necessary repairs to the supply closet in his office.

All voted aye.

A motion was made by Commissioner Lambert and seconded by Commissioner Reese to approve the minutes of previous meetings, as read by the County Clerk.

All voted aye.

A motion was made by Commissioner Reese and seconded by Commissioner Atwood to authorize Sheriff, Stuart Huffman, to have the 1977 Pontiac Patrol Car repaired at the South Main Paint and Body Shop, at a cost of \$624.40.

All voted aye.

Bob Cochran, representative of First Land & Title Company, appeared before the Court requesting that taxes for the year 1978 be reduced in Forrest Ridge addition since same had not been started in 1978. Mr. Cochran was informed that the court has no authority to lower taxes from a previous year.

A motion was made by Commissioner Atwood and seconded by Commissioner Aldridge to adjourn.
