BE IT REMEMBERED AT A REGULAR MEETING OF THE COMMISSIONERS' COURT IN AND FOR JOHNSON COUNTY, TEXAS, on the above-mentioned date at the Court-house in Cleburne, Johnson County, Texas, with the following members present: C.W. Atwood, Commissioner of Precinct No.1, A.J. Lambert, Commissioner of Precinct No.2, Loyd H. Reese, Commissioner of Precinct No.3, B.B. Aldridge, Commissioner of Precinct No.4, Tommy Altaras, County Judge and Joe L. Townes, County Clerk.

Invocation was given by A.J. Lambert, Commissioner of Precinct No.2.

At 9:10 A.M. court met in Executive Session to discuss a personnel matter.

Reconvened in open court at 9:18 A.M. with all members present with the following results:

The decision of the fact find board has determined that Sammy Glenn has not announced for the office of Justice of the Peace, and he will remain in the position of Constable, Precinct No.1, Johnson County.

Mr. E. L. Meredith, Chairman of the Board of Directors, Johnson County Committee on aging appeared before the court and presented a certificate of Appreciation to County Judge, Tommy Altaras, and County Commissioner, B.B. Aldridge, and personally thanked each one for their contribution to the program.

No action was taken by the court on the request of Mr. A.L. Ferguson to approve the plat of Alvarado Gardens, a sub-division just South of the City of Alvarado.

A motion was made by Commissioner Lambert and seconded by Commissioner Reese to approve the Revised Preliminary Plat of Mountain Valley Addition, Unit 5, Lots 1 thru 5, Block 11A, and lots 1 thru 5, Block 11-B - contingent upon Concord Drive containing a 60' right-of-way.

A motion was made by Commissioner Atwood and seconded by Commissioner Aldridge to approve County Treasurers Quarterly Report from July 1, 1979, to September 30, 1979.

No action was taken by the court on a suggestion from Commissioner A.J. Lambert to charge \$50.00 per road crossing by Public Utility Companies.

The County Judge is to check with the County Attorney in regard to State Statutes that govern County road crossings by public utilities.

A motion was made by Commissioner Atwood and seconded by Commissioner Lambert to approve the minutes of the previous meeting and special meeting, as read by the County Clerk.
