Meeting was called to order by Judge Altaras at 9:00 AM

REGARDING Item 1 of number I: Hospital bill for James Foote, a non-resident of the County, will not be paid.

REGARDING Item 2 of number I: Tabled to see if some of the office equipment that Tax Office left can be used.

REGARDING Item 3 of number I: See letter below

REGARDING Item 9, 10 and 15 of I: A motion was made by Commissioner Roe and seconded by Commissioner Russell to advertise for Bids for the new construction. All voted aye.

REGARDING Item number 7 of I: A motion was made by Commissioner Russell and seconded by Commissioner York to allow the National Association of Cushman Motor Scooter to use Precinct #1's barn for their Convention on June 28 & 29, 1985. All voted aye.

REGARDING Item number 13 of I: JOHNSON COUNTY MEDICAL SOCIETY
