New Indigent Care Bill - Dr Raines - General Discussion
10% of Total Budget must be for indigent Care
Will be effective January 1, 1985 If county is spending more then 10% then that county must keep up the same rate

Any thing over 10% the State allegly will take care of
Will need to set up Health Office consisting of Staff Phone, Ect.

Hospital is sending bills to prisoners in jail.
Commissioner will have County Attorney check on legality of prisoners having to pay for hospital bills that incur while in jail.

SHERIFF DEPARTMENT

Discussion of bills from Bill Jackson Wrecking service. Sheriff advised that it was from a drug bust, but thy the others were in storage before he took over office.

The other bill for patches, Sheriff advised that they were cheaper to by a larger number then one at a time and he purchased them so that they all would be uniform and that the deputies are buying them and the money they pay will go to general fund to pay back.
