ITEM # 1 Hogan Acres Phase VII & VIII Precinct 3

Motion by Commissioner York and seconded commission York to approve preliminary plat subject to city of Burleson approving preliminary plat and a resolution from the city of Wooded Hills given permission for the county to travel through Wooded Hills to maintain roads in Hogan Acres.
